SUBSIDIARY LEGISLATION

No. 1. THE BURIALS LAW, 1896.

ORDER MADE UNDER SECTION 14.

Whereas in pursuance of Notification No. 1106, published in the *Gazette* of the 20th September, 1935, a fit and proper site has been registered in the books of the Land Registry Office as a burial-ground for the burial of the dead by the Orthodox-Christian Community of the town of Nicosia, in the District of Nicosia :

Now, therefore, in exercise of the powers vested in him by section 14 of the Burials Law, 1896, His Excellency the Governor has been pleased to order and hereby orders that, from and after the 1st day of March, 1937, no burial shall take place in the burial-ground in lieu whereof the new burial-ground above referred to has been provided.

The Order dated the 19th day of July, 1936, and published under Notification No. 702 in the *Gazette* No. 2528 of the 24th day of July, 1936, is hereby revoked.

**No. 3. Notification under the Tree Planting Village Areas
Laws, 1930 to 1936.**

PALEOSOPHOS (KYRENIA) FUND.

In exercise of the powers vested in me by the Tree Planting Village Areas Laws, 1930 to 1936, I hereby establish a fund for the village of Paleosophos, in the District of Kyrenia, (hereinafter called the "Fund"), into which shall be paid all fines recovered under the said Laws for offences committed within the Tree Planting Area of the village of Paleosophos as described in the Order of the Governor made the 2nd December, 1936, and published in the *Cyprus Gazette* No. 2552 of the 4th December, 1936.

The Fund shall be under the management and control of the Commissioner of Kyrenia for the time being.

The money in the Fund shall be utilized for works of public utility in the village of Paleosophos.

**No. 4. Notification under the Tree Planting Village Areas
Laws, 1930 to 1936.**

VATILI (FAMAGUSTA) FUND.

In exercise of the powers vested in me by the Tree Planting Village Areas Laws, 1930 to 1936, I hereby establish a fund for the village of Vatili, in the District of Famagusta, (hereinafter called the "Fund"), into which shall be paid all fines recovered under the said Laws for offences committed within the Tree Planting Area of the village of Vatili, as described in the Order of the Governor made the 19th October, 1936, and published under Notification No. 1003 in the *Cyprus Gazette* of the 23rd October, 1936.

The Fund shall be under the management and control of the Commissioner of Famagusta for the time being.

The money in the Fund shall be utilized for works of public utility in the village of Vatili.
