**No. 42. THE BURIALS LAW, 1896.**

ORDER MADE UNDER SECTION 14.

Whereas in pursuance of Notification No. 1399, published in the *Gazette* of the 15th November, 1935, a fit and proper site has been registered in the books of the Land Registry Office as a burial-ground for the burial of the dead by the Orthodox-Christian Community of the village of Kato Moni, in the District of Nicosia :

Now, therefore, in exercise of the powers vested in him by section 14 of the Burials Law, 1896, His Excellency the Governor has been pleased to order and hereby orders that, from and after the 1st day of March, 1937, no burial shall take place in the burial-ground in lieu whereof the new burial-ground above referred to has been provided.

**THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.**

ORDER MADE UNDER SECTION 13.

Whereas at a meeting duly convened and held at the village of Salamiou, in the District of Paphos, on the 22nd day of November, 1936, it was determined by the requisite majority of the voters present thereat that two areas should be reserved as the Tree Planting Area of the village of Salamiou.

And whereas at the said meeting the boundaries of the said areas have been fixed and described :

And whereas the Mukhtar of the village of Salamiou has forwarded to the Commissioner of the District of Paphos a report, signed and sealed by him, containing a description with boundaries of the said areas and stating that the said areas fulfil the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed :

And whereas the said Commissioner has transmitted the said report, together with his recommendations, to the Colonial Secretary for the consideration of the Governor :

And whereas the Governor considers it expedient, having regard to all the circumstances, that the areas in the said report described should be reserved as the Tree Planting Area of the village of Salamiou :

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows :—

The areas described in the Schedule hereto are hereby declared to be and shall be reserved as the Tree Planting Area of the village of Salamiou in the District of Paphos.

#### SCHEDULE.

The areas lying within the following boundaries, that is to say :—

##### AREA " A " :

The boundary begins at the most northern point of plot No. 136, plan No. XLVI/44, locality "Vadhian," on the boundary of the village of Salamiou and on the south side of the road from the village of Kelokedhara to the village of Salamiou, and goes south-eastwards and north-eastwards along this side of this road to the most northern point of plot No. 323 of the same plan, locality "Konokhoma" ; thence south-eastwards along the north-eastern boundary of plot No. 323 of the same plan to the most southern point of plot No. 386 of the same plan, on a footpath ; thence south-eastwards along this footpath passing along the boundaries of, and including in the reserved area, plots Nos. 323, 322, 319, 318 of the same plan, plots Nos. 319, 318, 317, locality "Sklinidja," plots Nos. 343, 338, 340, 392, 393, 412, 413, 414, 449, 426, 427 and 431, plan No. XLVI/52, to the most southern point of plot No. 431, locality "Mutti-tou-Peni," on the boundary of the village of Salamiou ; thence south-westwards, north-westwards and northwards along this village boundary to the starting point.

##### AREA " B " :

The boundary begins at the most northern point of plot No. 445, plan No. XLVI/28, on the left bank of the stream "Vrysi-tou-Kolymbou," on the boundary of the village of Salamiou, and goes south-eastwards and north-eastwards along this village boundary to the most eastern point of plot No. 395, plan No. XLVI/29, locality "Dhyo Dhendra" ; thence south-eastwards and south-westwards passing along the boundaries of, and including in the reserved area, plots Nos. 395, 426, 425, 423, 421, 399, 402 of the same plan, locality "Plevra-tou-Papa," plots Nos. 258, 261, 486, 485, 483, 482, 481, 477, 475, 474, 470, 529, 530, 541, 542, 543, 544, 545, 546, locality "Kapsalia," plots Nos. 539, 538, 550, 549, 878, 772, 773, 877, locality "Kampos-tou-Monasteriou," plots Nos. 876, 799, 798, 796, 790, 789, 761, 760, plan No. XLVI/37, to the most southern point of plot No. 760, on the stream "Krya Vrysi" ; thence westwards

up this stream to the most western point of plot No. 619 of the same plan, locality "Konnarkes," on a track leading to the village of Salamiou; thence north-eastwards passing along the boundaries of, and including in the reserved area, plots Nos. 619, 618, 617, 616, 615, 614, 376, 602, 601, 600, locality "Kalonaris," plots Nos. 707, 708, 709, 592, 596, 591, 590, 589, 587, 586, 566, 565, 561, 560, to the stream at the north-western corner of plot No. 560, locality "Dhymma"; thence north-westwards up this stream to the most southern point of plot No. 32, of the same plan, locality "Asproyia"; thence south-westwards passing along the boundaries of, and including in the reserved area, plots Nos. 32, 239, 238, 237, 36, 37, 229, 228, 226, 46, 224, 223, 219, 217, 218, locality "Koudhellomandra," plots Nos. 194, 195, 190, 80, 81, 90, 89, 91 of the same plan to the south-eastern corner of plot No. 91, locality "Kyparissos," on a track; thence south-westwards and north-westwards along this track to the most western point of plot No. 100, plan No. XLVI/36, locality "Alonoui"; thence north-westwards passing along the boundaries of, and including in the reserved area, plots Nos. 100, 101, 104, 94, 93, 86, 85, 84, 124 of the same plan, locality "Vryses," plots Nos. 427, 426, 425, 424, 444, 445 to the starting point.

The areas reserved comprise 2,153 donums approximately, as shown edged in red on plan filed in D.L.R.S. M.P. 136/35.
