THE GOVERNMENT WATERWORKS LAW, 1928. 5

REGULATIONS MADE UNDER SECTION 34.

H. R. PALMER.

Governor.

In exercise of the powers vested in him by section 34 of the Government Waterworks Law, 1928, His Excellency the Governor, with the advice of the Executive Council, is pleased to make and hereby makes the following Regulations :--

1. These Regulations may be cited as the Irrigation Charges (Amendment) Regulations, 1937, and shall be read as one with the Irrigation Charges Regulations, 1931, (hereinafter called "the Principal Gazette: Regulations"), and the Principal Regulations and these Regulations may 4.12.31 together be cited as the Irrigation Charges Regulations, 1931 and 1937.

2. The Schedule to the Principal Regulations is hereby amended by the deletion of the words "Wheat or vetches" and the substitution therefor of the words "Wheat, vetches or flax".

The Customs Law, 1936.

NOTIFICATION.

NOTIFICATION UNDER SECTION 19A.

Lefkoniko Fund.

2. Regulation 6 of the Tree Planting (Lefkoniko) Village Area Regulations, 1934, shall cease to have effect as from this day.

NOTIFICATION UNDER SECTION 19A.

Salamiou (Paphos) Fund.

In exercise of the powers vested in me by the Tree Planting Village Areas Laws, 1930 to 1936, I hereby establish a fund for the village of Salamion, in the District of Paphos, (hereinafter called the "Fund"), into which shall be resident. shall be paid all fines recovered under the said Laws for offences committed within the Tree Planting Area of the village of Salamiou, as described in the Order of the Governor made the 18th February, 1937, and published in the Gazetle of the 26th February, 1937.

The Fund shall be under the management and control of the Commissioner of Paphos for the time being.

The money in the Fund shall be utilized for works of public utility in the village of Salamion.
