2. The following proviso shall be substituted for the proviso to paragraph 16 of the Principal Direction, Orders and Regulations :—

" Provided that during rough or foul weather or when passengers or any luggage are being landed or embarked at a place outside the limits of a port the owner or any boatman in charge of a licensed boat may charge such rates in excess of the rates set forth in the said Schedule as may be approved by the Superintendent of the Port."
