## ORDER IN COUNCIL No. 1867

In exercise of the powers vested in the Governor by section 3 of the Shop Hours Law, 1927, His Excellency the Acting Governor, with the advice of the Executive Council, has been pleased to order and it is hereby ordered as follows :-

1. This Order may be cited as the Shop Hours (Amendment) Order, 1939, and shall be read as one with the Shop Hours Orders, 1928 to Gazettes: (No. 2) 1934, (hereinafter called "the Principal Order") and the 28, 5.1928 Principal Order and this Order may together be cited as the Shop Hours Orders, 1928 - 1939.

ORDER IN COUNCIL No. 1868

hereby ordered as follows:—

In exercise of the powers vested in the Governor by section 6 of the Customs Laws, 1936 to (No. 2) 1938, His Excellency the Acting Governor, with the advice of the Executive Council, is pleased to order and it is

1. This Order may be cited as the Customs Houses (Days and Hours of Business) Order, 1939.

2. Subject to paragraph 3 of this Order all Customs Houses shall be open for the transaction of business on every day in the week as follows:—

From 1st June to 31st October in every year from 8 a.m. to noon and from 3 p.m. to 5 p.m.

From 1st November to 31st May in every year from 8 a.m. to noon and from 2 p.m. to 5 p.m.

- 3. All Customs Houses shall be closed for business on Sundays, Saturdays afternoon, Christmas Day, Boxing Day, New Year's Day, Good Friday, Easter Monday, Victoria Day and on any day appointed for the celebration of the King's Birthday.
- 4. Notwithstanding anything in this Order contained a Collector may give special permission for overtime work to be carried out by Customs Officers in the District in which he is appointed on any day at such rates as may be prescribed from time to time by the Comptroller for the services of such officers.
- 5. The Order of His Excellency the Governor published under Notification No. 324 of the Gazette dated 15th April, 1932, is hereby cancelled.

THE CUSTOMS LAWS, 1936 TO (No. 2) 1938.

ORDER IN COUNCIL No. 1869

In exercise of the powers vested in the Governor by section 52 of the Customs Laws, 1936 to (No. 2) 1938, His Excellency the Acting Governor, with the advice of the Executive Council, has been pleased to order and hereby orders as follows:—

- 1. This Order may be cited as the Import Duty (Packing Paper for Export of Powdered Umber) Exemption Order, 1939.
- 2. From and after the 21st day of July, 1939, all paper proved to the satisfaction of the Comi troller to be imported into the Colony solely for the purpose of being used for the lining of casks and barrels utilized in the export of powdered umber, shall be admitted into the Colony free from all import duties.
