THE EMERGENCY POWERS (CYPRUS DEFENCE)  
REGULATIONS, 1939.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 43.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 43 of the Emergency Powers (Cyprus Defence) Regulations, 1939, I hereby order as follows :—

1. This Order may be cited as the Defence (Returns of Stocks of Printing Paper) Order, 1939.

2. Within five days of the date of the publication of this Order in the *Gazette*, every person (whether such person is an importer, merchant, dealer or otherwise) who has in his possession or under his control any printing paper shall complete and deliver to me at Nicosia in duplicate a return, in the form set forth in the Schedule hereto, in respect of all stocks of printing paper in his possession or under his control.

3. Every person to whom this Order applies shall permit such person as I, or the Commissioner of the District, may authorize by writing in that behalf to enter upon his premises and make such enquiries or inspection of his books, invoices, accounts, documents or premises as may be necessary to ascertain the quantities or condition of printing paper in his possession or under his control or to check the correctness or accuracy of any return made by such person under this Order.

4. For the purposes of this Order, the term "printing paper" means printing paper, white or coloured, for use for printing newspapers, books, leaflets, pamphlets and posters.

5. Any person who—

(a) acts in contravention of the provisions of clause 2 or 3 of this Order, or

(b) makes a false return under clause 2 of this Order,

shall be liable to penalties prescribed in Regulation 63 (1) of the Emergency Powers (Cyprus Defence) Regulations, 1939.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 43.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 43 of the Emergency Powers (Cyprus Defence) Regulations, 1939, I hereby order as follows:—

1. This Order may be cited as the Defence (Regulation of Sale Prices) (Local Cheese) Amendment Order, 1939, and shall be read as one with the Defence (Regulation of Sale Prices) (Local Cheese) Order, 1939, (hereinafter called "the Principal Order"), and the Principal Order and this Order may together be cited as the Defence (Regulation of Sale Prices) (Local Cheese) Orders, 1939.

2. The Schedule to the Principal Order is hereby repealed and the following Schedule substituted therefor:—
