No. 417. THE DEFENCE REGULATIONS, 1940 TO (No. 3) 1940.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 61 of the Defence Regulations, 1940 to (No. 3) 1940, I hereby order as follows:—

1. This Order may be cited as the Defence (Sale of Tyres Control) Order, 1940.
2. For the purposes of this Order—

“tyres” means unused tyres for motor vehicles and includes unused inner tubes.

“Dealer in tyres” means any person who has in his possession or under his control any tyres for the purpose of sale by retail or by wholesale.

3. Within three days from the date of the publication of this Order, every dealer in tyres and every person who has in his possession or under his control any tyres exceeding two in number shall complete and deliver to me in duplicate a declaration in the form set forth in the Schedule hereto in respect of the tyres in his possession or under his control.

4.—(1) On and from the date of the publication of this Order no person shall withdraw any tyres from the Customs, save under a special permit issued under my hand.

(2) Every special permit issued under the provisions of paragraph (1) hereof may contain such terms and conditions (including the price at which the tyres are to be sold or purchased) as may be specified therein.

5. On and from the date of the publication of this Order no person shall buy or sell or otherwise dispose of, any tyres save under a permit issued by the Commissioner of the District in which the purchase, sale or disposal takes place.

6. Every dealer in tyres shall exhibit and keep exhibited at a conspicuous place on his premises a list showing the maximum price at which such tyres are offered for sale.

7. Every dealer in tyres shall keep on his premises a register showing the name of the purchaser of every tyre and the price at which the tyre was sold.

9. Any person who—

(a) acts in contravention of the provisions of this Order or of any of the terms and conditions specified in any permit issued under this Order; or

(b) makes under Clause 3 of this Order any declaration which is false in any material particular;

is liable to the penalties prescribed in Regulation 94 of the Defence Regulations, 1940 to (No. 3) 1940.
