**THE DEFENCE (CONTROL OF SALE PRICES OF SCHEDULED ARTICLES)
CONSOLIDATION ORDERS, 1940.**

NOTICE No. 14 UNDER CLAUSE 13.

A.—The Schedule is hereby amended by the addition to Part 1 of the following:—
“*Exception*: Where seed wheat is issued on deferred payment by the Director of Agriculture the prices may be as fixed by the Director of Agriculture.”

B.—The Schedule is hereby amended by the deletion therefrom of Part 6 and the substitution therefor of the following part:—

“PART 6.—COFFEE.

<i>Price when ground.</i> 36 piastres per oke.	<i>Retail Price.</i> 27 piastres per oke.	<i>Wholesale Price.</i> 24 piastres per oke.

In this Part of the Schedule—

the term ‘wholesale’ means sale or purchase of coffee in quantities in excess of 10 okes at any one time or at any single transaction.

Limitation: No person who has in his possession or under his control more than one bag of coffee of approximately 48 okes shall refuse to sell by wholesale.”

C.—The Schedule is hereby amended by the deletion therefrom of Part 17 and the substitution therefor of the following part:—

“PART 17.—LOCAL CHEESE.

Halloumi	20 piastres per oke	17 piastres per oke
Kaskavalli	26 piastres per oke	22 piastres per oke

the term ‘wholesale’ means sale or purchase of local cheese in quantities in excess of 5 okes at any one time or at any single transaction.”

D.—The Schedule is hereby amended by the deletion therefrom of Part 29 and the substitution therefor of the following part:—

“PART 29.—SUGAR.

No. 436. THE DEFENCE REGULATIONS, 1940 TO (No. 3) 1940.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 61 of the Defence Regulations, 1940 to (No. 3) 1940, I hereby order as follows:—

1. This Order may be cited as the Defence (Control of Weekly Sales of Sugar) Order, 1940, and shall come into operation on the date of its publication in the *Gazette*.

2. For the purposes of this Order—

“head of household” means, in the case of a dwelling-house, the head or the person acting as the head of the household, and in the case of any hotel or boarding-house the keeper or manager of such hotel or boarding-house.
