THE FOREST LAW, 1939.

ORDER IN COUNCIL No. 2002
MADE UNDER SECTION 3.

W. D. BATTERSHILL,
Governor.

I, the Governor in Council, in exercise of the powers conferred by section 3 of the Forest Law, 1939, do hereby order as follows:—

1, This Order may be cited as the Minor State Forest (Rizokarpaso Group) Order, 1941.

2. The areas of land and forests specified in Part I of the Schedule hereto, excluding the areas of land, and the immovable property other than land, specified in Part II of the said Schedule, are hereby declared to be Minor State Forests for the purposes of the Forest Law, 1939.
3. This Order shall come into operation on the 1st day of January, 1941.

ORDER IN COUNCIL No. 2003

MADE UNDER SECTION 3.

W. D. BATTERSHILL,

I, the Governor in Council, in exercise of the powers conferred by section 3 of the Forest Law, 1939, do hereby order as follows :—

1. This Order may be cited as the Minor State Forest (Trikomo Group) Order, 1941.
2. The areas of land and forests specified in Part I of the Schedule hereto, excluding the areas of land, and the immovable property other than land, specified in Part II of the said Schedule, are hereby declared to be Minor State Forests for the purposes of the Forest Law, 1939.
3. This Order shall come into operation on the 1st day of January, 1941.
