

THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1938.

ORDER IN COUNCIL No. 1918

MADE UNDER SECTION 78.

Whereas at a meeting of the Council of the Municipal Corporation of Nicosia held on the 17th November, 1939, it was decided upon a resolution of the required majority to sell the several sites of immovable property set out in the Schedule hereto situate in the town of Nicosia and registered in the name of the Municipal Corporation of Nicosia (hereinafter called "the immovable property");

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by section 78 of the Municipal Corporations Laws, 1930 to 1938, and with the advice of the Executive Council, is pleased to sanction and hereby sanctions the sale by private treaty of the immovable property by the Municipal Corporation of Nicosia:

Provided that the price in respect of each item of the immovable property shall not be less than the minimum price set out in the Schedule against each item of such property.
