THE TRADING WITH THE ENEMY LAWS, 1939 TO (No. 2) 1940.

ORDER MADE BY THE GOVERNOR UNDER SECTION 9.

- I, the Governor, in exercise of the powers conferred by section 9 of the Trading with the Enemy Laws, 1939 to (No. 2) 1940, do hereby order as follows:—
- 1. This Order may be cited as the Trading with the Enemy (Custodian) (Amendment) Order, 1941, and shall be read as one with the Trading with the Gazette: Enemy (Custodian) Order, 1940, (hereinafter referred to as "the principal Order"), Supplement and the principal Order and this Order may together be cited as the Trading with the Enemy (Custodian) Orders, 1940 and 1941.
- 2. Clause 2 of the principal Order is hereby amended by the deletion therefrom Deletion of of the definition of "company".

- 3. Clause 3 of the principal Order is hereby amended by the insertion at the Addition of end thereof of the following paragraph :-
 - "(5) Nothing in the foregoing provisions of this clause shall be taken to require payment to the Custodian of any money, the payment of which is authorized to some other person, under an authority given generally or principal specially by, or by any person authorized in that behalf by the Governor or Order. the Treasurer."
- 4. Clause 4 of the principal Order is hereby amended by the insertion at the Addition end thereof of the following paragraph :-
 - "(5) Notwithstanding anything in this Order contained any enemy property vested in the Custodian under the provisions of the Orders revoked by this Order shall be deemed to have vested in him under a vesting order made by the Governor under paragraph (1) of this clause."
- 5. Paragraph (3) of clause 7 of the principal Order is hereby amended as Amendment follows :-
 - (a) by the insertion after the word "company" (in line one) of the words (3) of clause 7 "incorporated in the Colony and every company which though not of principal incorporated in the Colony has a share transfer or share registration Order. office in the Colony";
 - (b) by the deletion of the word "company" (in line six) and the substitution therefor of the words "such company as aforesaid"
- 6. Clause 9 of the principal Order is hereby amended by the insertion after the Amendment word "Custodian" of the words "in respect of his general administrative of clause 9 expenses".
- 7. This Order shall be deemed to have come into operation on the 11th day of Commence-September, 1940.
