## THE GAME AND WILD BIRDS LAWS, 1934 AND 1938.

ORDER IN COUNCIL No. 2021  
MADE UNDER SECTION 15 (1) (a).W. D. BATTERSHILL,  
*Governor.*

I, the Governor in Council, in exercise of the powers conferred by section 15 (1) (a) of the Game and Wild Birds Laws, 1934 and 1938, and of every other power hereunto enabling, do hereby order as follows:—

1. This Order may be cited as the Game and Wild Birds (Shooting of Wild Birds) Order, 1941, and shall be read as one with the Order in Council No. 1755 of the 17th day of August, 1937, published in Supplement No. 3 to the *Gazette* of the 17th of August, 1937, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Game and Wild Birds (Shooting of Wild Birds) Orders, 1937 and 1941.

2. Paragraph (a) of clause 1 of the principal Order is hereby repealed and the following paragraph substituted therefor:—

"(a) to shoot, kill, take or pursue within any of the areas specified in the Schedule hereto any wild bird during the following part of the Close Season, that is to say, between the 21st day of January and the 31st day of March in every year, both days inclusive; and"
