#### No. 284. THE DEFENCE REGULATIONS, 1940 TO (No. 6) 1942.

DELEGATION OF POWERS UNDER PARAGRAPH (5) OF REGULATION 66.

I, the Governor, in exercise of the powers conferred by paragraph (5) of regulation 66 of the Defence Regulations, 1940 to (No. 6) 1942, do hereby depute the person for the time being holding the office designated in the second column of the Schedule hereto to exercise and perform on my behalf the powers mentioned in the first column of the said Schedule which I am empowered to exercise and perform under the provisions of paragraphs (1), (2), (3) and (4) of regulation 66 of the Defence Regulations, 1940 to (No. 6) 1942.

#### No. 285. THE DEFENCE REGULATIONS, 1940 TO (No. 7) 1942.

DELEGATION OF POWER UNDER PARAGRAPH (5) OF REGULATION 66.

I, the Governor, in exercise of the powers conferred by paragraph (5) of regulation 66 of the Defence Regulations, 1940 to (No. 7) 1942, do hereby depute the Controller of Transport to exercise and perform on my behalf the powers mentioned in the Schedule hereto, which I am empowered to exercise and perform under the provisions of paragraphs (1), (2), (3) and (4) of regulation 66 of the Defence Regulations, 1940 to (No. 7) 1942.

2. Nothing in this Order contained shall affect the operation and validity of the Order published under Notification No. 159 in Supplement No. 3 to the *Gazette* of the 30th June, 1941.

3.—(1) The Order published under Notification No. 144 in Supplement No. 3 to the *Gazette* of the 5th May, 1942, is hereby revoked.

(2) Any order of requisition made by the Controller of Transport under the provisions of the Order revoked by paragraph (1) of this clause shall be deemed to have been made under the provisions of this Order, and any reference in any such Order of requisition to the Order revoked by the said paragraph shall be construed as though it were a reference to this Order.

4. This Order shall be deemed to have been made on the 5th day of May, 1942.

#### SCHEDULE.

The power to requisition—

- (a) any mechanically propelled vehicle;
- (b) any part or fitting of any mechanically propelled vehicle;
- (c) any spare part of any mechanically propelled vehicle;
- (d) any outer cover or inner tube of any mechanically propelled vehicle whether such cover or tube is used or unused and whether it is on any mechanically propelled vehicle or not.
