THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1941.

BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF  
LIMASSOL.

In exercise of the powers vested in them by the Municipal Corporations Laws, 1930 to 1941, and otherwise, the Council of the Municipal Corporation of Limassol hereby make the following bye-laws:—

1. These bye-laws may be cited as the Municipal Corporation (Limassol) (Amendment) Bye-laws, 1942, and shall be read as one with the Municipal Corporation (Limassol) (Principal and Amended) Bye-laws, 1931 to (No. 2) 1935, (hereinafter called “the principal Bye-laws”) and the principal Bye-laws and these bye-laws may together be cited as the Municipal Corporation (Limassol) Bye-laws, 1931 to 1942.

2. The following shall be inserted in the principal Bye-laws between bye-law 170 and the expression “Part XV”:

“ PART XIVA.

LICENCES FOR STREET AND HOUSE-TO-HOUSE COLLECTIONS.

170A. No person shall, within the municipal limits, make or attempt to make any street and house-to-house collection for any charitable, philanthropic or other purpose unless such person or the institution or society or combination of which such person is a member shall have previously obtained a licence from the Council in that behalf.

170B. Every such licence shall state the date or dates, the manner and the time or times at which the collection to which the licence relates shall be made, and may contain such other terms and conditions as the Council may in each case determine.

170C. Every person who acts or attempts to act in contravention—

(a) of bye-law 170A, or

(b) of the provisions or terms or conditions of a licence granted under bye-law 170A,

shall be guilty of an offence against these bye-laws.”

The above bye-laws have been approved by His Excellency the Governor.
