## THE MUNICIPAL CORPORATIONS LAWS, 1930 AND 1942.

## ORDER IN COUNCIL No. 2061

MADE UNDER SECTION 206.

I, the Governor in Council, in exercise of the powers conferred by section 206 of the Municipal Corporations Laws, 1930 and 1942, do hereby order as follows :—

1. This Order may be cited as the Municipal Corporations Laws (Amendment of First Schedule) Order, 1942.

2. The First Schedule to the Municipal Corporations Laws, 1930 and 1942, is hereby amended as follows :—

(a) by the deletion from regulation 2 of the words " On or before the first day of January in every year, the town clerk shall make and sign " and the substitution therefor of the words " On the first day of January in every year, the town clerk shall prepare by signing " ;

(b) by the deletion from paragraph 5 of Form One thereof of the word " January " and the substitution therefor of the word " December " .

3. This Order shall be deemed to have been made and come into operation on the 27th day of November, 1942.

## THE MUNICIPAL CORPORATIONS (APPOINTMENT OF COUNCILS) LAW, 1938.

ORDER MADE UNDER SECTION 3.

*Governor.*

Whereas by sub-section (1) of section 3 of the Municipal Corporations (Appointment of Councils) Law, 1938, it is provided that no election for any council shall be had and no notice of election shall be prepared, signed and published under the provisions of the Municipal Corporations Laws, 1930 and 1942, until such year as the Governor shall by Order direct :

And whereas by sub-section (2) of section 3 of the Municipal Corporations (Appointment of Councils) Law, 1938, the operation of sections 9, 11 and 13 to 59 of the Municipal Corporations Laws, 1930 to 1942, and the First, Second, Third, Fourth and Fifth Schedules thereto have been suspended until such date as shall be specified in the Order of the Governor made under sub-section (1) of the said section :

Now, therefore, I, the Governor, in exercise of the powers conferred by section 3 of the Municipal Corporations (Appointment of Councils) Law, 1938, do hereby direct—

(a) that elections for councils shall be had and notices of elections shall be prepared, signed and published under the provisions

- of the Municipal Corporations Laws, 1930 and 1942, during the year 1943 ; and
- (b) that the suspension of the operation of sections 9, 11 and 13 to 59 of the Municipal Corporations Laws, 1930 and 1942, and of the First, Second, Third, Fourth and Fifth Schedules thereto shall cease as from the 30th day of November, 1942.
2. This Order shall be deemed to have been made and come into operation on the 30th day of November, 1942.

THE TRADES AND INDUSTRIES (REGULATION) LAWS,  
1937 AND 1942.

REGULATIONS MADE UNDER SECTION 14.

I, the Governor in Council, in exercise of the powers conferred by section 14 of the Trades and Industries (Regulation) Laws, 1937 and 1942, do hereby make the following regulations :—

1. These regulations may be cited as the Regulated Trades (Forms and Fees) (Amendment) Regulations, 1942, and shall be read as one with the Regulated Trades (Forms and Fees) Regulations, 1937, (hereinafter referred to as “ the principal Regulations ”), and the principal Regulations and these regulations may together be cited as the Regulated Trades (Forms and Fees) Regulations, 1937 and 1942.

2. Regulations 4 and 5 of the principal Regulations are hereby revoked.

3. Regulation 7 of the principal Regulations is hereby revoked and the following substituted therefor :—

“ 7. The fee to be charged in respect of every certificate of registration shall be two shillings and shall be payable in uncanceled stamps to the Commissioner at the time of the issue of the certificate.”

4. The Second Schedule to the principal Regulations is hereby amended as follows :—

(a) by the deletion therefrom of the words “ To the Commissioner of the District of..... ” and the substitution therefor of the words “ To the Commissioner of Labour.” ;

(b) by the deletion therefrom of paragraph 3.

5. The Third and Fourth Schedules to the principal Regulations are hereby revoked.

6. The Fifth Schedule to the principal Regulations is hereby amended by the deletion therefrom of the words “ Fee paid 1s.” and “ Commissioner of the District of..... ” wherever they occur and the substitution therefor of the words “ Fee: 2s. (Uncanceled stamps.) ” and “ Commissioner of Labour.” respectively.
