**THE DEFENCE (CONTROL OF SALE PRICES OF SCHEDULED ARTICLES) CONSOLIDATION ORDERS, 1940 TO 1942.**

**NOTICE NO. 91 UNDER CLAUSE 13.**

A.—The Schedule is hereby amended by the deletion therefrom of Part 23 and the substitution therefor of the following part:—

“PART 23.—KERCSENE.

Price for every four gallons in bulk	Price for every four gallons in new sealed tins ( <i>i.e.</i> with the tin).
74½ piastres. . . . .	87½ piastres.

*Modification:* The price for any lesser quantity of kerosene in bulk shall be:—

- (a) when sold by the oke in Sale's Centres a price not exceeding 7½ piastres per oke on the basis of 11 okes net per four gallons;
- (b) when sold by Mukhtars in villages other than Sale's Centres a price not exceeding 8¼ piastres per oke on the basis of 11 okes net per four gallons.

The price for any lesser quantity of kerosene ex new sealed tins shall be:—

- (a) when sold by the oke in Sale's Centres a price not exceeding 8½ piastres per oke on the basis of 11 okes net per four gallons;
- (b) when sold by Mukhtars in villages other than Sale's Centres a price not exceeding 9 piastres per oke on the basis of 11 okes net per four gallons.
