ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, I hereby order as follows:—

1. This Order may be cited as the Control of Cattle and Meat (Liveweight and Carcass Weight Prices) (Amendment) Order, 1943, and shall be read as one with the Control of Cattle and Meat (Liveweight and Carcass Weight Prices) Orders, 1942 (to No. 2) 1942, (hereinafter referred to as "the principal Order") and the principal Order and this order may together be cited as the Control of Cattle and Meat (Liveweight and Carcass Weight Prices) Orders, 1942 to 1943.

2. The Schedule to the principal Order is hereby amended by the deletion therefrom of Parts I and II and the substitution thereof of the following:—

1. In this part of the Schedule the term ‘carcass’—

(a) In item 1, means the whole of the dressed carcass including the head, liver and heart.

(b) In items 2, 3, 4, 5 and 6, means the whole of the dressed carcass including the head, liver, heart and lungs.

(c) In item 7, means the whole of the dressed carcass including the head, liver, heart, lungs and skin.

2. The prices in this part of the Schedule shall apply to and be in operation within the municipal limits of the towns of Nicosia, Limassol, Famagusta, Larnaca, Paphos and Kyrenia, and they shall include all charges incurred up to the time of the removal of the carcass from the slaughter-house.”
