THE DEFENCE (CONTROL OF SALE PRICES OF SCHEDULED ARTICLES)
CONSOLIDATION ORDERS, 1940 TO 1942.

NOTICE No. 108 UNDER CLAUSE 13.

A.—The Schedule is hereby amended by the addition thereto of the following Part :—

“PART 74.—METHYLATED SPIRITS.

Type of Methylated spirit.	Retail price.	Wholesale price.
Denatured or methylated spirits (locally known as Spirito tou Kaminetou) of a minimum Strength of 80° Gay Lussac or 40° over proof “ Sykes Hydrometer.”	2s. & 2p. per oke.	2s. per oke.

In this Part of the Schedule—

the term ‘oke’ means one eighth of a kouza or 1.1/8 quarts (as defined in the Weights and Measures Law, 1890).

the term ‘wholesale’ means sale or purchase of Methylated spirits in quantities of not less than 40 okes or 5 kouzas at any one time or at any single transaction.”

B.—The Schedule is hereby amended by the addition thereto of the following Part :—

“PART 75.—MIXED WHEAT AND BARLEY FLOUR.

(1)	(2)
All towns and villages	4 piastres and 5 paras per oke.

Definitions :

‘Mixed wheat and barley flour’ means an admixture of 70 okes of imported flour or whole wheat flour or of both and 30 okes of barley flour.

‘Whole wheat flour’ and ‘barley flour’ shall have respectively the same meaning as in the Defence (Control of Bakeries and Bread) Orders, 1942 and 1943.”

THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, I hereby order as follows :—

1. This order may be cited as the Defence (Licensing of Dealers of Certain Goods) Amendment Order, 1943, and shall be read as one with the Defence (Licensing of Dealers of Certain Goods) Orders, 1942 to (No. 5) 1942, (hereinafter referred to as “the principal Order”), and the principal Order and this order may together be cited as the Defence (Licensing of Dealers of Certain Goods) Orders, 1942 to 1943.

2. The principal Order is hereby amended by the deletion from the First Schedule of item 10 and the substitution therefor of the following :—

“ 10. Flour :

(a) Imported,

(b) An admixture of 70% of wheat flour and 30% barley flour.”
