In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, I hereby order as follows:—

1. This order may be cited as the Defence (Dispensation of Drugs) Amendment Order, 1943, (hereinafter referred to as "the principal Order"), and the principal Order and this order may together be cited as the Defence (Dispensation of Drugs) Orders, 1942 and 1943.

2. The Schedule to the principal Order is hereby repealed and the following Schedule substituted therefor:—

No. 205. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.

✕ ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, I hereby order as follows:—

1. This order shall be cited as the Control of Livestock Order, 1943.

2. In this Order:—

"livestock" means sheep, goats, pigs, and the young of the same.

3. Within seven days of the publication of this Order in the *Gazette*, every person shall complete and deliver—

- (a) in the case of a person residing in or carrying on business in a town, to the Commissioner of the District; or  
 (b) in the case of a person residing in or carrying on business in a village, to the Mukhtar of the village in which he resides,

a return setting out the number of each of the following classes of livestock in his possession, or under his control :—

4. From and after the publication of this order in the *Gazette*, no person shall buy, sell, or otherwise dispose of any livestock except under permit from the Senior Stock Inspector or Stock Inspector of the district in which the seller resides :

Provided that nothing in this clause contained shall apply to young pigs weighing less than ten okes.

5. Within three days from the day on which any person buys or sells or otherwise disposes of any livestock, such person shall furnish the Senior Stock Inspector or Stock Inspector of the district in which he resides with a statement in writing setting out the name and address of the person from whom he has bought, or to whom he has sold or otherwise disposed of such livestock :

Provided that nothing in this clause contained shall apply to young pigs weighing less than ten okes.

6. Notwithstanding anything contained in this order, no permit shall be required for the buying and selling or otherwise disposing of livestock where both the buyer and seller are resident in the same village; provided that the livestock are not subsequently moved out of the village area, and provided that the transfer of ownership is, within 24 hours, reported to the Mukhtar.

7. Any person that I may authorize in writing in that behalf may enter upon any place or premises and make enquiries or inspection therein as may be necessary for the purpose of ascertaining whether the provisions of this order have been or are being complied with.

8. Any person who—

- (a) contravenes or fails to comply with any of the provisions of this order ;  
 (b) makes a return or statement which is false in any material particular ;  
 (c) knowingly misleads or otherwise interferes with or impedes any person exercising any powers or performing any duties under the provisions of this order ;

is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 1) 1943.

9. The provisions of this order shall be in addition to and not in derogation of the Cattle and Meat Orders, 1942.

## No. 206. THE CONTAGIOUS DISEASES (ANIMALS) LAW, 1880.

### ORDER UNDER SECTION 2(1)(i).

In exercise of the powers vested in the Governor by section 2(1)(i) of the Contagious Diseases (Animals) Law, 1880, duly deputed to me under section 4 of the said Law by paragraph 2 of the Notification No. 527 published in the *Gazette* of the 3rd July, 1931, I, Robert Moylan Gambles, Acting Chief Veterinary Officer, hereby order as follows :—

1. No person shall carry, lead, or drive any bull, cow, ox, heifer, calf, camel, sheep, goat, pig, or the young of the same, into the area covered by buildings, quays, railway, and roads lying between the easterly defence walls of Famagusta town and the sea from the Citadel to the Jambulat Bastion inclusive.

2. Nothing in this Order shall prevent the importation or exportation of animals through Famagusta port under permit from the Director of Agriculture.
