THE DEFENCE (CONTROL OF SALE PRICES OF SCHEDULED ARTICLES)
CONSOLIDATION ORDERS, 1940 TO 1942.

NOTICE No. 114 UNDER CLAUSE 13.

A.—The Schedule is hereby amended by the deletion therefrom of Part 8 and the substitution thereof of the following part :—

“PART 8.—LOCAL OLIVE OIL.

(1)	(2)	(3)	(4)
Type of local olive oil	Price to producers	Retail price	Wholesale price.
Olive oil of less than 5% acidity.	8s. and 4½p. per litre	8s. and 8p. per litre or 3s. and 5p. per oke	8s. and 3p. per litre.
Olive oil of acidity 5% to 8% inclusive.	8s. per litre		

In this part of the Schedule—
the term ‘wholesale’ means sale of local olive oil by Government Distribution Centres.”

B.—The Schedule is hereby amended by the deletion therefrom of Parts 22, 23 and 24 and the substitution thereof of the following parts respectively :—

“PART 22.—GAS OIL.

(1)	(2)
Price per Metric Ton.	Price for lesser quantity.
£17. 6s.	Proportionately to the price in column (1).

Modification:

Provided that where gas oil is sold in new sealed tins the price of each tin containing 4 gallons will be 7s. 3p.

PART 23.—KEROSENE.

(1)	(2)
Price for every four gallons in bulk.	Price for every four gallons in new sealed tin (i.e. with the tin).
50½ piastres.	63½ piastres.

Modification: The price for any lesser quantity of kerosene in bulk shall be :—

- when sold by the oke in Sale’s Centres a price not exceeding 5½ piastres per oke on the basis of 11 okes net per four gallons ;
- when sold by Mukhtars in villages other than Sale’s Centres a price not exceeding 6¼ piastres per oke on the basis of 11 okes net per four gallons.

The price for any lesser quantity of kerosene ex new sealed tins shall be :—

- when sold by the oke in Sale’s Centres a price not exceeding 6½ piastres per oke on the basis of 11 okes net per four gallons ;
- when sold by Mukhtars in villages other than Sale’s Centres a price not exceeding 7 piastres per oke on the basis of 11 okes net per four gallons.

PART 24.—PETROL.

(1)	(2)
Price for every 4 gallons in bulk ex pump, sleeve cap tin or 2-gallon can.	Price for every 4 gallons in new sealed tin (i.e. with tin).
12 shillings and 3½ piastres	13 shillings and 7½ piastres.”

C.—The Schedule is hereby amended by the deletion therefrom of Part 36 and the substitution therefor of the following part:—

“PART 36.—POTATOES.

(1)	(2)
Retail Price	Wholesale Price
5½ piastres per oke.	4½ piastres per oke.

Limitation: All persons having in their possession or under their control more than 200 okes of potatoes shall sell only at wholesale prices.

In this part of the Schedule—

the term ‘wholesale’ means sale or purchase of potatoes in quantities of not less than 40 okes at any one time or at any single transaction.”

D.—Part 66 of the Schedule (relating to Local Leather) is hereby amended by the deletion therefrom of item 9 and the substitution therefor of the following:—

“Item 9.—Box (Leather from calf):

Black or brown 1s. 7½p. per sq. ft.
Other than black or brown 1s. 3p. per sq. ft.

E.—The Schedule is hereby amended by the addition thereto of the following:

“Part 76.—Lemons.

(1)	(2)
Retail price	Wholesale price
1½ piastres each.	1¼ piastres each.

In this part of the Schedule—

the term ‘wholesale’ means sale or purchase of lemons in quantities of not less than 100 lemons at any one time or at any single transaction.”

No. 274. THE DEFENCE REGULATIONS, 1940 TO (No. 1) 1943.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 1) 1943, I hereby order as follows:—

1. This Order may be cited as the Defence (Control of Local Hides and Local Leather) Amendment (No. 2) Order, 1943, and shall be read as one with the Defence (Control of Local Hides and Local Leather) Orders, 1942 and 1943, (hereinafter referred to as “the principal Order”), and the principal Order and this Order may together be cited as the Defence (Control of Local Hides and Local Leather) Orders, 1942 to (No. 2) 1943.

2. Sub-clause (1) of clause 10 of the principal Order is hereby amended as follows:—
(a) by the deletion from paragraph (a) thereof of the word “goat”;
(b) by the insertion in paragraph (b) thereof immediately after the words “of any” of the word “goat”.
