No. 302. THE GAME AND WILD BIRDS LAWS, 1934 TO 1941.

ORDER IN COUNCIL No. 2092.

I, the Governor in Council, in exercise of the powers conferred by section 14 of the Game and Wild Birds Laws, 1934 to 1941, and of every other power hereunto enabling, do hereby order as follows:—

1. This Order may be cited as the Game Reserve Areas (Amendment) Order, 1943, and shall be read as one with the Game Reserve Areas Orders, 1938 and 1941, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Game Reserve Areas Orders, 1938 to 1943.

2. The Schedule to the principal Order is hereby amended by the deletion therefrom of Area No. 6 (Larnaca District).

No. 303. THE FOREST LAW, 1939.

ORDER IN COUNCIL No. 2093

MADE UNDER SECTION 3.

C. C. WOOLLEY,

I, the Governor in Council, in exercise of the powers conferred by section 3 of the Forest Law, 1939, do hereby order as follows:—

1. This Order may be cited as the Minor State Forests (Amendment) Order, 1943, and shall be read as one with the Minor State Forests Order, 1943, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Minor State Forests Orders, 1943.

2. The Schedule to the principal Order is hereby amended by the addition at the end thereof of the following areas:—

~~"9. *Tysi* in the District of Famagusta :~~

~~Commencing at the most northern point of plot 200 of Sheet XXXII, Plan 13E and W; thence north-westwards along the north-eastern boundaries of plots 198, 199 and 191 of the same plan to a point on the northern boundary of plot 191, distant 380 feet from its north-east corner; thence northerly in a straight line, a distance of 210 feet; thence south-easterly in a direction parallel to and distant 200 feet from the southerly boundary of the area as described above to a point~~

200 feet north of the starting point; thence southerly in a straight line, a distance of 200 feet to the starting point. The extent of the area is 13 donums and 3 evleks approximately and forms part of the Kouklia Reservoir; it is situate in the village of Kouklia, at the locality 'Shiromandra', Famagusta District.

10. *Kondea in the District of Famagusta:*

Commencing from the most easterly corner of plot 208 of Sheet XXXII, Plan 13E and W, and proceeds north-westwards along the north-eastern boundaries of plots 208, 207, 203, 201 and the northern boundary of plot 200 up to the most northern corner of plot 200; thence northwards in a straight line, a distance of 190 feet; thence south-eastwards in a direction parallel to and 180 feet from the western boundary of the area as described above to a point opposite the most easterly corner of plot 208 as aforesaid; thence south-westwardly in a straight line to point of commencement. The extent of the area is 18 donums approximately and forms part of the Kouklia Reservoir: it is situate in the village of Kouklia, at the locality 'Shiromandra', Famagusta District."

No. 304. THE TRADING WITH THE ENEMY LAWS, 1939 TO 1941.

I, the Governor, in exercise of the powers conferred by sub-sections (1) and (5) of section 2 of the Trading with the Enemy Laws, 1939 to 1941, do hereby vary the Order published in Supplement No. 3 to the *Gazette* of the 31st July, 1940, under Notification No. 286, by the deletion therefrom of paragraphs (b), (c) and (d) relating to Algeria, the French zone of Morocco and Tunisia, respectively.

This Order shall be deemed to have come into operation on the 15th July, 1943.

No. 305. THE FOREST REGULATIONS, 1940 TO 1942.

NOTICE UNDER REGULATION 6.

It is hereby notified for general information that in virtue of the authority vested in him by regulation 6 of the Forest Regulations, 1940 to 1942, His Excellency the Governor has been pleased to declare that the Minor State Forests, the areas of which are set out in the Schedule to the Minor State Forests Orders, 1943, published in Supplement No. 3 to the *Gazettes* of the 7th January, 1943 and the 26th August, 1943, under Notifications Nos. 1 and 303, respectively, shall be reserved as Village Fuel Areas.

2. The notice published in Supplement No. 3 to the *Gazette* of the 7th January, 1943, under Notification No. 2, is hereby cancelled without prejudice to anything done thereunder.
