I, the Governor, in exercise of the powers conferred by section 13 (2) of the Tree Planting Village Areas Laws, 1930 to 1936, do hereby order that the Order relating to the Tree Planting Area of the village of Galataria, published in the *Gazette* of the 9th March, 1934, under Notification No. 300, shall, except in so far as it relates to the part of the said Tree Planting Area described in the Schedule hereto, be extended for a further period of five years from the date of the expiration thereof.

SCHEDULE.

The boundary of the area commences at the north-western corner of plot No. 673 of the Government Survey Plan No. XLVI/18 on the boundary of the village of Galataria and proceeds eastwards, southwards and north-eastwards along the boundaries of and including plots Nos. 673, 665, 666, 670, 671, 669, 746, 744, 743, locality "Kholetres", 711, 712, 731, 730, 721, 722 and 724 of the Government Survey Plan No. XLVI/18 to the most northern point of the last-mentioned plot; thence south-eastwards along the boundaries of and including plots Nos. 724, 726 and 737 of the said plan, plots Nos. 3, 4, 5, 7, 21, 178, 177, 45, 46, 47, 48, 49, 136, 135, 137, 138, 174, 175, 176 and 178 of the Government Survey Plan No. XLVI/19 to the road at the most western point of plot No. 179 of the said plan, locality "Mosphilia"; thence south-eastwards along the said road to the left bank of the stream at the most eastern point of plot No. 166 of the said plan, locality "Karias"; thence westwards along the left bank of the said stream to the road at the most western point of plot No. 660, plan No. XLVI/18, locality "Agrioclia"; thence northwards along this road to the fork of roads at the most northern point of plot No. 659 of the said plan; thence south-westwards along the road from the village of Galataria to the village of Pentalia to the most southern point of plot No. 658 of the said plan, on the boundary of the village of Galataria; thence northwards along the said village boundary to the point of commencement, all which said area comprises 582 donums approximately and is shown edged in red on the Government Survey Plan Serial No. 1293.

No. 107.**THE PRISON DISCIPLINE LAW, 1879.****REGULATIONS MADE UNDER SECTION 4.**

2. Schedule C of the principal Regulations (relating to dietary) is hereby amended by the addition thereto of the following part immediately after the end of Part II :—

“PART III.

The Resident Superintendent of the Central Prison may at his discretion issue such extra diets as he may think fit to any persons who perform special work on the Central Prison Farm.”
