In exercise of the powers vested in him by section 6 of the Land Acquisition Laws, 1899 to 1944 and with reference to the Notification dated the 19th day of February, 1944, and published under No. 63 in Supplement No. 3 to the *Gazette* of the 24th February, 1944, His Excellency the Governor has been pleased to sanction and hereby sanctions the acquisition, under the provisions of the said Laws, of the immovable properties situated in the town of Nicosia, Ibrahim Pasha Quarter, of the District of Nicosia, particulars whereof are specifically set out in the Schedule hereto:—

No. 173. THE CYPRUS GOVERNMENT RAILWAY LAW, 1906.

AUTHORIZATIONS GRANTED UNDER SECTION 4.
