THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

ORDER MADE UNDER SECTION 13.

In exercise of the powers vested in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, His Excellency the Governor is pleased to order and it is hereby ordered as follows:—

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village of Ayia Phyla, in the District of Limassol.

SCHEDULE.

The area lying within the following boundaries, that is to say:—

The boundary commences at the most northern point of plot No. 274 of the Government Survey Plan No. LIV.41 at the junction of two roads, locality "Vikla" and proceeds south-eastwards along the road to the junction of roads at the most eastern point of plot No. 82 of the Government Survey Plan No. LIV.42, locality "Vounaridhia" which point is also on the boundary of the village of Ayia Phyla; thence southwards along the said village boundary to the most southern point of plot No. 5 of the Government Survey Plan No. LIV.58, locality "Kapsali"; thence northwards and westwards along the boundaries of and including in the reserved area plot No. 5 of the said plan, plots Nos. 175, 168 and 167 of the Government Survey Plan No. LIV.50, plots Nos. 4, 3, 1 and part of plot No. 7 of the Government Survey Plan No. LIV.58, plot No. 217 of the Government Survey Plan No. LIV.49, plots Nos. 253, 252, 251, 254, 249 and 247 of the Government Survey Plan No. LIV.57 to the mile post No. 1 on the Limassol-Paphos main road; thence north-westwards along the said main road to the south-west corner of plot No. 246 of the said plan, on a road; thence north-west along the said road to the most southern point of plot No. 197 of the Government Survey Plan No. LIV.49; thence north-westwards along the boundaries of and including plots Nos. 197, 142 and 133 of the said plan to the most western point of plot No. 133, on a footpath; thence northwards along the said footpath to a road at the most western point of plot No. 127 of the said plan, locality "Ayios Yeorghios"; thence northwards along the said road to the most northern point of plot No. 101 of the said plan; thence south-eastwards along the boundaries of and including in the reserved area plots Nos. 101 and 102 of the said plan to the north-eastern corner of plot No. 102 on a road; thence south-eastwards along the said road to the cross-roads at the most southern point of plot No. 158 of the said plan, locality "Pefkota"; thence north-eastwards along the road through localities "Halospita", "Kafkalla", "Kokkinokambos", "Gypsokamina" and "Xerolakkos", to the starting point, all which said area comprises 2,355 donoms or thereabouts and is shown edged in red on the plan filed in D.L.R.S. M.P. 129/43.
