**No. 215. THE FOREST LAW, 1939.**

**ORDER IN COUNCIL No. 2125**

**MADE UNDER SECTION 3.**

I, the Governor in Council, in exercise of the powers conferred by section 3 of the Forest Law, 1939, do hereby order as follows :—

1. This Order may be cited as the Minor State Forests (Nicosia, Kyrenia and Paphos) (Amendment No. 3) Order, 1944, and shall be read as one with the Minor State Forests (Nicosia, Kyrenia and Paphos) Orders, 1942 to (No. 2) 1944, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Minor State Forests (Nicosia, Kyrenia and Paphos) Orders, 1942 to (No. 3) 1944.

2. The Schedule to the principal Order is hereby amended by the addition at the end thereof of the following area :—

"29. *Morphou in the District of Nicosia :*

All that area situated at the locality 'Livadhia', in the village of Morphou near the sea shore, demarcated by boundary stones numbered 7 to 17 inclusive, being part of plot No. 233 of the Government Survey Plan No. XIX/6 and shown on the Government Survey Plan Serial No. 1294. The extent of the area is 237 donums approximately."

**No. 216. THE FOREST REGULATIONS, 1940 TO 1944.**

**NOTICE UNDER REGULATION 6.**

It is hereby notified for general information that in virtue of the authority vested in him by regulation 6 of the Forest Regulations, 1940 to 1944, His Excellency the Governor has been pleased to declare that the Minor State Forests, the areas of which are set out in the Schedule to the Minor State Forests (Nicosia, Kyrenia and Paphos) Orders, 1942 to (No. 3) 1944, shall be reserved as Village Fuel Areas.

2. The notice published in Supplement No. 3 to the *Gazette* of the 10th February, 1944, under Notification No. 34, is hereby cancelled without prejudice to anything done thereunder.
