THE DEFENCE REGULATIONS, 1940 TO 1944.

ORDER MADE BY A COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to 1944, I hereby order as follows:— 1. This Order may be cited as the Defence (Returns of Stocks of Carobs) Order,

1944.

In this Order— "carobs" mean whole carobs, kibbled carobs, meal of carobs and carob kernels.

- 3. Within three days from the date of the publication of this Order in the Gazette every person who has in his possession or under his control any carobs in excess of one ton shall complete and deliver to me a declaration in the form set forth in the First Schedule hereto in respect of the carobs in his possession or under his control.
- 4. Not later than six days after the last day of each month, commencing from the month of June, 1944, any person who has in his possession or under his control any carobs in excess of one ton shall complete and deliver to me a separate return of his dealings in carobs in respect of the carob crop of 1941 and previous years, of 1942 and of 1943, in the form of, and containing the particulars set out in, the Second Schedule to this Order.
- 5. Every person shall permit such person as I or the Commissioner of the District may authorize in writing in that behalf, to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with, or for the purpose of checking the correctness or accuracy of any return made under the provisions of this Order.
