

No. 244. THE DEFENCE REGULATIONS, 1940 TO 1944.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to 1944, I hereby order as follows:—

1. This Order may be cited as the Defence (Control of Sale of Cattle) Order, 1944.
2. In this Order—
 - “cattle” means bulls, cows, oxen, heifers and calves;
 - “purchase” includes—
 - (i) any offer or agreement to purchase;
 - (ii) any attempt to purchase;
 - (iii) any arrangement to purchase made either directly or indirectly;
 - “sell” includes—
 - (i) any offer or agreement to sell;
 - (ii) any attempt to sell;
 - (iii) any arrangement to sell made either directly or indirectly.
3. From and after the date of the publication of this Order in the *Gazette* no person shall sell, dispose of, purchase or acquire any cattle save under a permit in writing from a Senior Stock Inspector or a Stock Inspector.
4. Every person shall permit such person as I may authorize in writing in that behalf to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with.
5. Any person who—
 - (a) acts in contravention of, or fails to comply with, any of the provisions of this Order;
 - (b) knowingly misleads or otherwise interferes with or impedes any person exercising any powers or performing any duties under the provisions of this Order,
 is liable to the penalties prescribed in regulations 61 and 94 of the Defence Regulations, 1940 to 1944.
6. The Control of Cattle Order, 1943, is hereby revoked without prejudice to anything done or left undone thereunder.
