No. 31. THE CHANGE OF TITLES LAW, 1934.

ORDER IN COUNCIL No. 2113

MADE UNDER SECTIONS 4 AND 6.

I, the Governor in Council, in exercise of the powers conferred by sections 4 and 6 of the Change of Titles Law, 1934, do hereby order—

- (a) that the title in the First and Second Columns of the First Schedule hereto be added to the First and Second Columns respectively of the First Schedule to the Change of Titles Law, 1934, with effect from the 1st January, 1944;
- (b) that the title in the First and Second Columns of the Second Schedule hereto be added to the First and Second Columns respectively of the Second Schedule to the above-mentioned Law with effect from the same date.

No. 32. THE FOREST LAW, 1939.

ORDER IN COUNCIL No. 2114

MADE UNDER SECTION 3.

C. C. WOOLLEY,
Governor.

I, the Governor in Council, in exercise of the powers conferred by section 3 of the Forest Law, 1939, do hereby order as follows:—

1. This Order may be cited as the Minor State Forests (Nicosia, Kyrenia and Paphos) (Amendment No. 2) Order, 1944, and shall be read as one with the Minor State Forests (Nicosia, Kyrenia and Paphos) Orders, 1942 to 1944, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Minor State Forests (Nicosia, Kyrenia and Paphos) Orders, 1942 to (No. 2) 1944.

2. The Schedule to the principal Order is hereby amended by the addition at the end thereof of the following areas:—

" 24. *Ayios Vasilios in the District of Nicosia:*

A portion of the hali land at the locality 'Aspros' demarcated by boundary stones from D254 to D259 inclusive, comprising 25 donums approximately and shown on the Government Survey Plan Serial No. 1286.

25. *Alambra in the District of Nicosia :*

A portion of the hali land at the locality 'Salikkos' demarcated by boundary stones from D223 to D232 inclusive, comprising 10½ donums approximately and shown on the Government Survey Plan Serial No. 1287.

26. *Pyroi in the District of Nicosia :—*

The whole area of the hali land under plot No. 128 of the Government Survey Plan No. XXXI. 34, comprising 19½ donums approximately and shown on the Government Survey Plan Serial No. 1288.

27. *Ayia Varvara in the District of Nicosia :*

A portion of the hali land at the locality 'Makrya Rashi' demarcated by boundary stones from D233 to D238 inclusive, comprising 19 donums approximately and shown on the Government Survey Plan Serial No. 1289.

A portion of the hali land at the locality 'Sitos' demarcated by boundary stones from D239 to D253 inclusive, comprising 20 donums approximately and shown on the Government Survey Plan Serial No. 1290."

THE POST OFFICE LAWS, 1881 TO 1933.

ORDER IN COUNCIL No. 2115

MADE UNDER SECTION 6.

I. 6. 44, p. 131. I, the Governor in Council, in exercise of the powers conferred by section 6 of the Post Office Laws, 1881 to 1933, do hereby order as follows:—

1. This Order may be cited as the Post Office (Air Mail Rate of Postage) Order, 1944.

2. There shall be charged a combined Postage and Air fee, in addition to late and/or registration fees, at the rates set forth in the third and fourth columns of the Schedule hereto, on letters, printed papers, commercial papers, samples, small packets and postcards intended for transmission by air mail to any of the countries of destination enumerated in the first column of the said Schedule, such transmission to be effected—

- (a) by air or surface route from the Colony to Egypt or Palestine; and
(b) from Egypt or Palestine to the country of destination either wholly by air or partially by air and partially by surface route.

3. The Post Office (Air Mail Rate of Postage) Orders, 1942 to (No. 3) 1943, are hereby revoked.
