No. 337. THE ELEMENTARY EDUCATION LAWS, 1933 TO 1944.

ORDER MADE UNDER SECTION 71.

Acting Governor.

Whereas His Excellency the Governor has, under section 52 of the Elementary Education Laws, 1933 to 1944, ordered the Committee of Management for Maronite Schools to provide school buildings, premises, playgrounds, yards, gardens or teachers' dwellings in the villages mentioned in the second column of the Schedule hereto :

And whereas the necessary estimates and plans have been prepared under section 53 of the above-mentioned Laws :

And whereas loans amounting to the sums mentioned in the third column of the Schedule hereto have under section 51 (1), been raised to meet the expense of providing such buildings as aforesaid :

Now, therefore, in pursuance of the powers vested in the Governor by section 71 of the Elementary Education Laws, 1933 to 1944, His Excellency the Acting Governor has been pleased to order and it is hereby ordered that in order to provide for the annual interest and sinking fund in respect of the loans aforesaid the sums of money mentioned in the fourth column of the said Schedule hereto be recovered from the Maronite taxpayers of the villages mentioned in the second column of the said Schedule in manner provided by section 74 of the said Laws.
