**No. 140. THE CYPRUS VOLUNTEER FORCE LAWS, 1940 TO 1944.**

**PROCLAMATION MADE UNDER SECTION 11A.**

I, Charles Campbell Woolley, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Officer of the Most Excellent Order of the British Empire, upon whom has been conferred the Decoration of the Military Cross, Governor and Commander-in-Chief in and over the Colony of Cyprus, in exercise of the powers vested in me by section 11A of the Cyprus Volunteer Force Laws, 1940 to 1944, and of every other power thereunto enabling, do hereby, by this Proclamation, demobilize Captain A. N. Houry.

Given under my hand and the Public Seal of the Colony at Nicosia, this 22nd day of May, 1945.

**No. 141. THE CUSTOMS LAWS, 1936 TO (No. 2) 1944.**

**ORDER IN COUNCIL No. 2164**

**MADE UNDER SECTION 52.**

I, the Governor in Council, in exercise of the powers conferred by section 52 of the Customs Laws, 1936 to (No. 2) 1944, do hereby order as follows:—

1. This Order may be cited as the Customs (Prohibition and Restriction of Imports) (Amendment) Order, 1945, and shall be read as one with the Customs (Prohibition and Restriction of Imports) Orders, 1936 to (No. 2) 1939, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Customs (Prohibition and Restriction of Imports) Orders, 1936 to 1945.

2. The principal Order is hereby amended as follows:—

(a) by the deletion from the First Schedule thereto of item 5 (the subsequent items being renumbered accordingly):

(b) by the insertion in the Third Schedule thereto of the following item:—

"4. Old or used clothes for the purpose of sale or commerce."

**No. 142. THE CYPRUS VOLUNTEER FORCE LAWS, 1940 TO 1944.**

**DIRECTION UNDER SECTION 10.**

**C. C. WOOLLEY,**  
*Governor.*

I, the Governor, in exercise of the powers conferred by section 10 of the Cyprus Volunteer Force Laws, 1940 to 1944, do hereby direct as follows:—

Officers and other ranks of the Cyprus Volunteer Force, when called out and mobilized for actual service, shall, subject to any other special direction as may be given by the Governor or to any special order as may be issued by the Commander-in-Chief, Middle East Forces, or an officer acting under his authority, wear the same

uniform as prescribed for the officers and members of the Cyprus Regiment, when serving in Cyprus.

Officers and other ranks of the Cyprus Volunteer Force, when not called out and mobilized for actual service, shall not wear any such uniform as hereinbefore described nor any other uniform authorized for use by His Majesty's Forces.

**THE DEFENCE (CONTROL OF SALE PRICES OF SCHEDULED ARTICLES)  
CONSOLIDATION ORDERS, 1940 TO 1942.**

**NOTICE No. 167 UNDER CLAUSE 13.**

The Schedule is hereby amended, with effect from the 24th May, 1945, by the deletion therefrom of Parts 22, 84 and 85 and the substitution thereof of the following Parts respectively:—

**"PART 22.—GAS OIL.**

Price per metric ton ex warehouse in drums.	Price delivered in bulk to customers' premises.	Price ex warehouse in drums for any quantity less than 1 metric ton.

*Modifications:* Provided that—

- (a) the price in column (2) shall apply to sales or purchases of not less than 4 tons at any one time or at any single transaction, on condition that purchasers shall provide their own storage;
- (b) where gas oil is delivered at the customers' premises in Nicosia within a radius of 3 miles from the Commissioner's office, the price for quantities exceeding 65 gallons shall be £11. 7s. per metric ton and for quantities of less than 65 gallons the price shall be 3 shillings and 5 piastres per 4 gallons."

**"PART 84.—DIESEL OIL.**

- (b) where diesel oil is delivered at the customers' premises in Nicosia within a radius of 3 miles from the Commissioner's office, the price for quantities exceeding 65 gallons shall be £11. 3s. per metric ton."

**"PART 85.—FURNACE OIL.**

- (b) where furnace oil is delivered at the customers' premises in Nicosia within a radius of 3 miles from the Commissioner's office, the price for quantities exceeding 65 gallons shall be £9. 16s. per metric ton."
