## No. 251. THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1944.

BYE LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF KYTHREA.

In exercise of the powers vested in them by the Municipal Corporations Laws, 1930 to 1944, and otherwise, the Council of the Municipal Corporation of Kythrea hereby make the following bye laws:-

1. These bye-laws may be cited as the Municipal Corporation (Kythrea) Amendment Bye-laws, 1945, and shall be read as one with the Municipal Corporation (Kythrea) Bye-laws, 1932 to 1939, (hereinafter referred to as "the principal Bye-laws). laws") and the principal Bye-laws and these bye-laws may together be cited as the Municipal Corporation (Kythrea) Bye-laws, 1932 to 1945.

2. The principal Bye-laws are hereby amended by the insertion immediately

2. The principal pye-laws are hereby amended by the factor by law 58 of the following bye-law —

"58A.—(1) Every owner or occupier of any land situated along or near the banks of Xeropotamos shall keep the bed of Xeropotamos clear from the roots of any tree, plant or bush on such land, protruding or advancing into such bed.

(2) No person shall cover a reference of thing to be placed or deposited.

(2) No person shall cause or suffer any matter or thing to be placed or deposited in or upon the bed of Xeropotamos so as in any way to obstruct or interfere with

the free flow of water in, or to reduce the width of, such bed.

(3) In this bye-law the term 'Xeropotamos' means the channel (within the municipal limits) shown on the Kythrea Land Registration and Survey Plan as the 'Xeropotamos Channel' along which rain water gathering from the northern bills flows and which after supplies the same takes a southerly direction, hills flows and which after running through Kythrea takes a southerly direction, and includes its tributaries and branches.
