(a) any assignment of a chose in action;

(b) any transfer of a negotiable instrument; and

(c) any transfer of any coupon or other security transferable by delivery, not being a negotiable instrument, being an assignment or transfer made on or after the 20th August, 1945, by or on behalf of a person to whom this Order applies.

3. This Order applies-

(a) to any individual resident in Denmark;

(b) as respects any business carried on in Denmark, to any individual or body of persons (whether corporate or unincorporate) carrying on that business;

(c) as respects any business carried on in any territory which is neither enemy territory nor an area which is for the time being to be treated as enemy territory for the purposes of section 6 of the Law in accordance with the provisions of section 12A or 12B of the Law, to any body of persons (whether corporate or unincorporate) carrying on that business if and so long as the body is controlled by any individual resident in, or body of persons carrying on business in, Denmark.

 - (a) any money which would but for the existence of a state of war become payable to or for the benefit of any person within the description contained in clause 3 of this Order on or after the 3rd September, 1945;

(b) any property which on or after the 3rd September, 1945, comes into the

ownership of any such person as aforesaid;

(c) any money or property to which the above-mentioned clauses would apply only because any such persons as aforesaid became resident or commenced or recommenced to carry on business in Greece on or after the 3rd September, 1945.

3. This Order applies-

(a) to any individual resident in Greece;

(b) as respects any business carried on in Greece to any individual or body of persons (whether corporate or unincorporate) carrying on that business:

(c) as respects any business carried on in any territory which is neither enemy territory nor an area which is for the time being to be treated as enemy territory for the purposes of section 9 of the Law in accordance with the provisions of section 12A or section 12B of the Law, to any body of persons (whether corporate or unincorporate) carrying on that business if and so long as controlled by any individual resident in, or body of persons carrying on business in, Greece.

4. This Order shall be deemed to have come into operation on the 3rd September, 1945.
