No. 394. THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1945.

ORDER IN COUNCIL No. 2179

MADE UNDER SECTION 91 (5).

I, the Acting Governor in Council, in exercise of the powers conferred on the Governor in Council by section 91 (5) of the Municipal Corporations Laws, 1930 to 1945, and of every other power thereunto enabling, do hereby order—

- (a) that the Schedule to the Order in Council No. 2147, published in Supplement No. 3 to the *Gazette* of the 21st December, 1944, shall be amended by the deletion therefrom of the Municipal Corporation of Lefka;
- (b) that the Order in Council No. 2158 (relating to the Municipal Corporation of Lefkara), published in Supplement No. 3 to the *Gazette* of the 22nd March, 1945, shall be revoked.

THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND 1940.

REGULATIONS MADE BY THE ACTING GOVERNOR.

I, the Acting Governor, in exercise of the powers conferred on the Governor by the Emergency Powers (Defence) Acts, 1939 and 1940, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1942, do hereby make the following regulations:—

1. These regulations may be cited as the Defence (Amendment No. 4) Regulations 1945, and shall be read as one with the Defence Regulations, 1940 to (No. 3) 1945, (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Defence Regulations, 1940 to (No. 4) 1945. *Gazettes:*

2. Regulation 40 of the principal Regulations is hereby amended as follows:—
 - (a) by the insertion in paragraph (1) thereof immediately after the words "any premises" (occurring in lines 1 and 12) of a comma and the words "place or area";
 - (b) by the deletion in paragraph (1) thereof of the words "those premises" (occurring in lines 6 and 9) and the substitution therefor of the words "such premises, place or area";
 - (c) by the deletion in paragraphs (2) and (3) thereof of the word "premises" and the substitution therefor of the words "protected place".
3. Any order made under regulation 70 of the principal Regulations shall be deemed to be an order made under regulation 40 of the principal Regulations as amended by these regulations and shall be valid and effective notwithstanding that regulation 70 of the principal Regulations is repealed.
4. These regulations shall be deemed to have been made and to have come into operation on the 10th day of May, 1945.
