- I, the Governor in Council, in exercise of the powers conferred by section 6 of the Quarantine Law, 1932, do hereby make the following
- 1. These regulations may be cited as the Quarantine (Amendment) Gazettes: Regulations, 1946, and shall be read as one with the Quarantine Regulations, 1932 to 1939, (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Quarantine Regulations, 1932 to 1946.

2. The Note in the Third Schedule to the principal Regulations is hereby deleted and the following Note substituted therefor:

"Note.—For the purposes of this Schedule the hours of business

shall be as follows:-

(a) From the 1st June to the 31st October in every year—

(i) on Mondays, Tuesdays, Thursdays and Fridays, from 8 a.m. to noon and from 3 p.m. to 6 p.m.

(ii) on Wednesdays, from 8 a.m. to noon and from 3 p.m. to 5 p.m.;

(iii) on Saturdays, from 8 a.m. to noon.

(b) From the 1st November in every year to the 31st May of the following year—

(i) on Mondays, Tuesdays, Wednesdays, Thursdays and Fridays, from 8 a.m. to noon and from 2 p.m. to 5 p.m.;

(ii) on Saturdays, from 8 a.m. to noon."
