No. 131.**THE COMPANIES (LIMITED LIABILITY) LAWS, 1922 TO 1944.****LICENCE UNDER SECTION 20.**

Whereas it has been proved to the satisfaction of His Excellency the Governor that The Social Progress Society which is about to be registered as a company with limited liability under the Companies (Limited Liability) Laws, 1922 to 1944, is formed for the purpose of promoting objects of the nature contemplated by section 20 (1) of the said Laws and that it is the intention of the said Society that the income and property thereof whensoever derived shall be applied solely towards the promotion of the objects of the Society as set forth in the Memorandum of Association of the said Society and that no portion thereof shall be paid or transferred, directly or indirectly, by way of dividend or bonus or otherwise howsoever, by way of profit to its members or to any of them, or to any person claiming through any of them.

Now, therefore, in pursuance of the powers vested in the Governor by section 20 of the Companies (Limited Liability) Laws, 1922 to 1944, and in consideration of the provisions and subject to the conditions contained in the Memorandum of Association of the said Social Progress Society as subscribed by eighteen members thereof and approved by the Court on the 19th December, 1945, His Excellency the Governor does by this licence direct The Social Progress Society to be registered with limited liability, without the addition of the word "Limited" to its name.
