THE SUMMER RESORTS (DEVELOPMENT) LAW, 1938.

BYE-LAWS MADE BY THE SUMMER RESORT DEVELOPMENT  
BOARD FOR TROODOS.

In exercise of the powers vested in them by the Summer Resorts (Development) Law, 1938, the Summer Resort Development Board for Troodos hereby make the following bye-laws :—

1. These bye-laws may be cited as the Summer Resort Development (Troodos) (Amendment No. 2) Bye-laws, 1945, and shall be read as one with the Summer Resort Development (Troodos) Bye-laws, 1941 and 1945, (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Summer Resort Development (Troodos) Bye-laws, 1941 to (No. 2) 1945.

2. Bye-law 83 of the principal Bye-laws is hereby repealed and the following bye-law substituted therefor :—

"83.—(1) A fee, to be determined in each case by the Board, not exceeding twenty shillings per month, shall be paid by the owner or occupier of any premises within the Summer Resort for the removal of each bucket or other receptacle containing night-soil, fluid refuse or household refuse.

(2) Every such fee shall be paid to the person authorised by the Board in that behalf."

The above bye-laws have been approved by His Excellency the Governor.

No. 198. The Irrigation Divisions (Villages) Laws, 1938 and 1944.

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Laws, 1938 and 1944, the following rules made by the Committee of the Irrigation Division of "Meridjes-Vassilika and Limni" Vatili, in the District of Famagusta, are published in the *Gazette*.

IRRIGATION DIVISION OF "MERIDJES-VASSILIKA AND LIMNI" VATILI.

*Rules.*

1. These Rules may be cited as the Irrigation Division of "Meridjes-Vassilika and Limni" Vatili Rules, 1945.

2. In these rules, unless the context otherwise requires—

"Commissioner" means the Commissioner of the District of Famagusta;

"Committee" means the Committee of the Irrigation Division;

"Irrigation Division" means the Irrigation Division of "Meridjes-Vassilika and Limni" Vatili;

"Law" means the Irrigation Divisions (Villages) Laws, 1938 and 1944;

"list" means the list of the names and residence of the proprietors and of the lands and extent thereof which are to be benefited or are capable of being benefited by the works prepared under the provisions of section 15 of the Law as finally settled under the provisions of section 16 of the Law;

"works" means the irrigation works of the Irrigation Division.

3. The Committee shall hold office for a period of three years beginning on the 16th December, 1945. Thereafter the election of the Committee shall take place every third year in the first week of the month of December and it shall hold office for a period of three years from the day next following its election.
