THE FOREST LAW, 1939.

ORDER IN COUNCIL No. 2198

MADE UNDER SECTION 3.

C. C. WOOLLEY,

I, the Governor in Council, in exercise of the powers conferred by Section 3 of the Forest Law, 1939, do hereby order as follows:—

1. This order may be cited as the Minor State Forests (Nicosia, Kyrenia and Paphos) (Amendment) Order, 1946, and shall be read as one with the Minor State Forests (Nicosia, Kyrenia and Paphos) Orders, 1942 to (No. 3) 1944, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Minor State Forests (Nicosia, Kyrenia and Paphos) Orders, 1942 to 1946.

2. The Schedule to the principal Order is hereby amended by the deletion therefrom of the areas Nos. 5, 9 and 24 (relating to the villages of Kythrea, Paleometokho and Ayios Vassilios, respectively), and the substitution therefor of the following areas:—

"5. *Kythrea in the District of Nicosia:*

Portions of plots Nos. 123 and 113 and the whole of plot No. 116 of Block 'B' Khardakiotissa Quarters of Kythrea (Sheet XIII, plan 59 W. and E.) at the locality 'Anephani' and 'Strongylovounarou' demarcated by boundary stones numbered consecutively from 1 to 46, inclusive, comprising 132 donums and 1 evlek approximately and shown on the Government Survey Plan Serial No. 1325, delineated thereon in green.

9. *Paleometokho in the District of Nicosia:*

A portion of the hali land under plot No. 227 of sheet XX, plan No. 63, at the locality 'Mavromazka' demarcated by boundary stones numbered consecutively from 1 to 34, inclusive, comprising 139 donums and 1 evlek approximately and shown on the Government Survey Plan Serial No. 1326, delineated thereon in green.

24. *Ayios Vassilios in the District of Nicosia:*

A portion of the hali land at the locality 'Aspros', sheet XX, plan Nos. 16 and 24, demarcated by boundary numbered consecutively from 1 to 18, inclusive, comprising 84 donums and 1 evlek approximately and shown on the Government Survey Plan Serial No. 1327, delineated thereon in green."
