NOTICE UNDER REGULATION 6.

It is hereby notified for general information that in virtue of the authority vested in him by regulation 6 of the Forest Regulations, 1940 to 1944, His Excellency the Governor has been pleased to declare that—

- (a) the Minor State Forests, the areas of which are set out and numbered 1 to 4 and 6 to 29, both inclusive, in the Schedule to the Minor State Forests (Nicosia, Kyrenia and Paphos) Orders, 1942 to 1946, shall be reserved as Village Fuel Areas;
- (b) the Minor State Forest, the area of which is set out and numbered 5 (relating to the village of Kythrea) in the Schedule to the Minor State Forests (Nicosia, Kyrenia and Paphos) Orders, 1942 to 1946, shall be reserved as a Municipal Fuel Area.

2. The notice published in Supplement No. 3 to the *Gazette* of the 22nd June, 1944, under Notification No. 216, is hereby cancelled without prejudice to anything done thereunder.

- (a) the Municipal Fuel Area (relating to the village of Kythrea) reserved under Notification No. 221 published in Supplement No. 3 to the *Gazette* of the 27th day of June, 1946; and
- (b) the Fund to be established in respect of the said Municipal Fuel Area in accordance with the provisions of regulation 12 of the Forest Regulations, 1940 to 1944,

shall be under the control of the Council of the Municipal Corporation of Kythrea.

I, the Governor in Council, in exercise of the powers conferred by section 3 of the Forest Law, 1939, do hereby order as follows:—

1. This Order may be cited as the Minor State Forests (Famagusta) (Amendment) Order, 1946, and shall be read as one with the Minor

State Forests (Famagusta) Orders, 1943 to (No. 2) 1944 (hereinafter referred to as "the principal Order") and the principal Order and this Order may together be cited as the Minor State Forests (Famagusta) Orders, 1943 to 1946.

2. The Schedule to the principal Order is hereby amended as follows:—

(a) by the deletion therefrom of the area No. 15 (relating to the village of Angastina) and the substitution therefor of the following area:—

"15. *Angastina in the District of Famagusta:*

A portion of hali lands under plots Nos. 372.9 and 372.10 and plots Nos. 372.6 and 277 of sheet XXII plan 3 of E. and W. at the locality 'Moustafouri' demarcated by boundary stones numbered consecutively from 1 to 21, inclusive, comprising 113 donums and 3 evleks approximately and shown on the Government Survey Plan Serial No. 1317 delineated thereon in green."

(b) by the addition thereto immediately after area No. 19 (relating to the village of Koukklia) of the following areas:—

"20. *Yenagra in the District of Famagusta:*

Parts of plots Nos. 129, 176 and plot No. 177 of sheet XXIII, plan No. 19 W. at the locality 'Dolap Kougoulari' demarcated by boundary stones numbered consecutively from 1 to 5, inclusive, comprising 10 donums and 3 evleks approximately and shown on the Government Survey Plan Serial No. 1321 delineated thereon in green.

21. *Yialousa in the District of Famagusta:*

A portion of hali land under plot No. 1 of sheet III, plan No. 19 W., at the locality 'Patelles' demarcated by boundary stones numbered consecutively from 1 to 13, inclusive, comprising 132 donums and 1 evlek approximately and shown on the Government Survey Plan Serial No. 1322 delineated thereon in green.

22. *Trikomo in the District of Famagusta:*

All the areas of plots Nos. 37, 38 and 138 of sheet XV, plan No. 43 E., and sheet XV, plan No. 51 E., at the locality 'Lishines' demarcated by boundary stones numbered consecutively from 1 to 23, inclusive, comprising 190 donums approximately and shown on the Government Survey Plan Serial No. 1323 delineated thereon in green.

23. *Lapathos in the District of Famagusta:*

A portion of hali land under plot No. 356 of sheet XIV, plan No. 56 E., at the locality 'Kokkinokamino' demarcated by boundary stones numbered from 1 to 3, 14 and 4 to 9, inclusive, comprising 60 donums approximately and shown on the Government Survey Plan Serial No. 1324 delineated thereon in green and marked 'A'.

24. *Syngrasi in the District of Famagusta:*

A portion of hali land under plot No. 276 of sheet XIV, plan No. 64 E., at the locality 'Trahonas' demarcated by boundary stones numbered from 1 to 14, inclusive, 3 and 2, comprising 367 donums approximately and shown on the Government Survey Plan Serial No. 1324 delineated thereon in green and marked 'B'."
