## NOTIFICATION UNDER SECTION 6.

C. C. WOOLLEY,

*Governor.*

With reference to the Notifications published in Supplement No. 3 of the *Gazette* of the 4th October, 1945, under Nos. 275 and 276 (relating respectively to the declaration of the Limassol Town Committee for Greek-Orthodox Schools, in their capacity as the Governing Body of the Greek-Orthodox Secondary Schools in the town of Limassol, as a public body for the purposes of the Land Acquisition Laws, 1899 to 1945, and to the declaration of the erection of a public Secondary School at Limassol as an undertaking of public utility under the above-mentioned Laws);

And with reference to the Notice of the Commissioner of Limassol published in Supplement No. 3 of the *Gazette* of the 8th of November, 1945, under No. 344 (giving particulars of the lands required by the Governor for the undertaking above-mentioned);

I, the Governor, in exercise of the powers conferred by the Land Acquisition Laws, 1899 to 1945, do hereby sanction the acquisition under the provisions of the said Laws of the immovable properties situated in the town of Limassol particulars whereof are specifically set out in the Schedule hereto, any compensation or cost involved in such sanction to be borne by the public body hereinbefore mentioned.

## SCHEDULE.

All the lands under the following plots, together with all structures, wells and trees standing thereon :—

- (a) Plots Nos. 180/1, 180/2, 181, 182/1, 182/2, 185.1/2, 185.1/3, 185.1/4, 185.1/5, 185.1/6, 185.1/7, 185.1/8, 185.1/9, 185.1/10, 185.1/11, under Survey Plans LIV.50.5.iii and LIV.50.5.iv; and
- (b) Plots Nos. 104.1, 84/2, 84/3/1, 85/2, 86/1, 85/3/2, 90/1/1, 86/4, 86/3, 86/2/1, 87, 89/1, 88/4, 88/5/1, and 88/6/1 under Survey Plans LIV.58.2.i and LIV.58.2.ii.

The boundaries of the said lands are :—

Embankment of Vathia river (belonging to the Municipal Corporation of Limassol), plot 183 Field of Theklou Christoforou of Mesayitonia, plot 185.2/1 Building site of Ioanni Patiki, road, plot 185.2/12 Building site of Ioanni Patiki, road, plot 185.2/11 Building site of Chrysantho Nicola, plot 185.2/10, Building site of Stelios Georghiou and Gregorou Steliou, road, plot 185.2/9 House and yard of Ioanni Patiki, plot 185.1, House and yard of Costa Kyriacou Antoniadi, plot 185.1/1 House and yard of Polyxeni Constantinou, Vassili Michaelidi street, Bye-pass road and road to Ayia Phyla.
