## PRESCRIPTION OF GROUPS.

## ORDER MADE UNDER SECTION 6 (2).

I, the Governor, in exercise of the powers conferred by section 6 (2) of the Elementary Education Laws, 1933 to 1944, and of every other power thereunto enabling, do hereby order and prescribe as follows :—

1. This Order may be cited as the Elementary Education (Prescription of Groups) Amendment Order, 1946, and shall be read as one with the Elementary Education (Prescription of Schools) Orders, 1944, (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Elementary Education (Prescription of Schools) Orders, 1944 to 1946.

2. The Third Schedule to the principal Order is hereby amended as follows :—

- (a) by the deletion therefrom of the words "Pera Khorio—Nisou" and "Potamia—Ayios Sozomenos" in column 2 under the heading "Nicosia District" and "Pretori—Philousa" in column 2 under the heading "Paphos District" in respect of the Greek-Orthodox religious community ;
- (b) by the insertion therein in the proper alphabetical order of the words "Kophinou—Skarinou" in column 2 under the heading "Larnaca District" in respect of the Greek-Orthodox religious community ;
- (c) by the insertion therein in the proper alphabetical order of the words "Akoursos—Kathikas" in column 2 under the heading "Paphos District" in respect of the Greek-Orthodox religious community ;
- (d) by the deletion therefrom of the words "Sellain t'Api—Alevga—Ayion Yeorghoudhi" in column 2 under the heading "Nicosia District" in respect of the Moslem religious community and the substitution therefor of the words "Sellain t'Api—Ayion Yeorghoudhi" ;
- (e) by the deletion therefrom of the words "Livadhia—Ayios Evstathios" in column 2 under the heading "Famagusta District" in respect of the Moslem religious community.

3. The Fourth Schedule to the principal Order is hereby amended by the deletion therefrom of the words "Akacha—Dhenia" and "Angolemi—Koutraphas (Pano and Kato)" under the heading "Nicosia District" and "Photta—Ayios Ermolaos" under the heading "Kyrenia District".
