

3. No person shall remove, sell or dispose of or attempt to remove, sell or dispose of any caustic soda save under a permit in writing under my hand or under the hand of any person or persons authorized by me in writing in that behalf. Such permit may be general or in respect of a particular transaction and may contain such terms, limitations and conditions as may be specified therein.

4. Every person shall permit such person or persons as I may authorize in writing in that behalf to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with, or for the purpose of checking the correctness or accuracy of any return made by such person under clause 2 of this Order.

5. Any person who—

- (a) acts in contravention of, or fails to comply with, any of the provisions of this Order ;
- (b) makes any false statement in any application for a permit under this Order ;
- (c) fails to comply with any term, limitation or condition in any permit issued under this Order ;
- (d) knowingly misleads or otherwise interferes with or impedes any person exercising any powers or performing any duties under the provisions of this Order ;

is liable to the penalties prescribed in the Defence Regulations as set out in the First Schedule to the Supplies and Services (Transitional Powers) (Cyprus) Order, 1946.
