## A PROCLAMATION.

Whereas it is expedient to amend the boundaries of the village of Ayia Phyla and Katholiki Quarter of Limassol in the District of Limassol :

Now, therefore, in exercise of the powers vested in the Governor by section 17 of the Village Authorities Laws, 1931 to (No. 2) 1937, and otherwise, I, Roland Evelyn Turnbull, Companion of the Most Distinguished Order of Saint Michael and Saint George, Acting Governor and Commander-in-Chief in and over the Colony of Cyprus, do hereby order and proclaim that from and after the 1st day of January, 1947, the area described in the Schedule hereto, heretofore reckoned within the boundaries of the village of Ayia Phyla, shall form part of the lands of the Katholiki Quarter of Limassol and that the boundaries of the said village of Ayia Phyla and the Katholiki Quarter of Limassol shall be altered accordingly.

## SCHEDULE.

The boundary of the area commences at the north-western corner of plot No. 255 of the Government Survey Plan No. LIV/57 on the left bank of the old Garyllis river and proceeds eastwards, southwards and north-eastwards along the boundaries of and including plots Nos. 255 of the said plan, 9/6 of the Government Survey Plan No. LIV/57.3.III 9/4 and 9/5 of the Government Survey Plan No. LIV/58.1.III to the most northern point of the latter plot on the main road from the "Pitsillia" to Limassol ; thence south-eastwards along the said main road for a distance of 150 feet approximately to the point where it meets the boundary of the village of Ayia Phyla ; thence southwards and westwards along the said village boundary to the point of commencement, all which said area is shown coloured violet and hatched yellow on the Government Survey Plan Serial No. 1330.

In exercise of the powers vested in the Governor by section 17 of the Village Authorities Laws, 1931 to (No. 2) 1937, and otherwise, I, Roland Evelyn Turnbull, Companion of the Most Distinguished Order of Saint Michael and Saint George, Acting Governor and Commander-in-Chief in and over the Colony of Cyprus do hereby order and proclaim that from and after the 1st day of January, 1947 :—

(1) the boundary of the town of Limassol shall be as set forth in Schedule A hereof ;

(2) the town of Limassol comprised within the boundary aforesaid shall be divided into the Quarters set forth in Schedule B hereof ;

*Boundary of the Town of Limassol.*

The boundary commences at the most southern point of plot No. 56/1 of the Government Survey Plan LIX/9 on the seashore and on the boundary of the village of Zakaki and proceeds northwards along the said village boundary to the north-western corner of plot No. 174 of the Government Survey Plan LIX/1 where it meets the boundary of the village of Kato Polemidhia ; thence northwards along the last mentioned village boundary to the south-eastern corner of plot No. 162 of the Government Survey Plan LIV/57, at a junction of roads ; thence northwards along the road to the village of Polemidhia to the north-western corner of plot No. 160 of the said plan, locality " Koutsoullia " ; thence north-eastwards along the boundaries of and including plots Nos. 160, 157, 156, 155, 154, 137, 124 and 126 of the said plan to the most northern point of plot No. 126 of the said plan on the right bank of the new Garyllis river ; thence northwards along the said bank of this river to its junction with the old Garyllis river at the most northern point of plot No. 244 of the said plan ; thence south-eastwards along the old bed of Garyllis river to the north-western corner of plot No. 255 of the said plan ; thence north-eastwards along the boundaries of and including plot No. 255 of the said plan and plot No. 9 of the Government Survey Plan LIV/58 to the most northern point of the latter plot on the Pitsillia-Limassol main road ; thence south-eastwards along the said road for a distance of 150 feet approximately to the most western point of plot No. 36 of the said plan on the boundary of the village of Ayia Phyla ; thence north-eastwards along the said village boundary to its junction with the boundary of the village of Mesayitonia at the north-western corner of plot No. 405 of the Government Survey Plan LIV/50, locality " Kapsalos " ; thence eastwards along the said village boundary to its junction with the boundary of the village of Ayios Athanasios on the left bank of the Vathia river at the north-western corner near plot No. 87 of the Government Survey Plan LIV/51, locality " Arghaki " ; thence south-eastwards along the said river to the seashore ; thence south-westwards along the seashore to the point of commencement, all which said area is shown edged black on the Government Survey Plan Serial No. 1330.

QUARTERS OF THE TOWN OF LIMASSOL.

*Ayios Nicolas Quarter.*

The boundary commences at the most southern point of plot No. 371 of the Government Survey Plan LIV/50 on the boundary of the village of Mesayitonia and proceeds north-eastwards along the said village

boundary to the point where it meets the boundary of the village of Ayios Athanasios on the bed of the Vathia river at the north-western corner of plot No. 87 of the Government Survey Plan LIV/51, locality " Arghaki"; thence south-eastwards along the said river to the point where it crosses George V Street; thence south-westwards along the said George V Street to its junction with Canning Street; thence northwards and westwards along the said Canning Street to its junction with Byron Street at the Mile Post No. 53; thence north-westwards along the street which is a continuation of Byron Street to its junction with Anapafsis Street at the most northern point of plot No. 6 of the Government Survey Plan LIV/58.3.II; thence south-westwards along the said Anapafsis Street to the point where it crosses the Vathia river at the most southern point of plot No. 116/2 of the said plan; thence north-westwards along the said Vathia river to the south-western corner of plot No. 114 of the said plan; thence northwards along the boundary of and including the said plot to the Limassol peripheral road at a point where a new street leading to plot No. 414/112 of the Government Survey Plan LIV/50.6.III leaves the said peripheral road; thence north-westwards along the said new street to its junction with another street at the most northern point of plot No. 414/111 of the said plan; thence westwards along the said street to the south-western corner of plot No. 414/112 of the said plan; thence north-westwards and north-eastwards along the boundaries of and including plot No. 414/112 of the said plan, plots Nos. 392 and 390 of the Government Survey Plan LIV/50 to the point of commencement, all which said area is shown coloured red on the Government Survey Plan Serial No. 1330.

*Ayia Zoe Quarter.*

The boundary commences at the point at which the Limassol-Ayia Phylaxis road crosses the Vathia river on the boundary of the village of Ayia Phyla and proceeds north-eastwards along the said village boundary to its junction with the boundary of the village of Mesayitonia at the north-western corner of plot No. 405 of the Government Survey Plan LIV/50 locality " Kapsalos "; thence eastwards along the said village boundary to the most southern point of plot No. 371 of the said plan; thence southwards along the boundaries of and excluding plots Nos. 390 and 392 of the said plan and plot No. 414/112 of the Government Survey Plan LIV/50.6.III to the street at the most southern point of the latter plot; thence eastwards along the said street to its junction with a street at the most northern point of plot No. 414/111 of the said plan; thence south-eastwards along the last mentioned street to its junction with the Limassol peripheral road; thence south-westwards and southwards along the boundary of and excluding plot No. 114 of the Government Survey Plan LIV/58.3.II to the Vathia river; thence westwards along the said Vathia river to the north-eastern corner of plot No. 1/13 of the Government Survey Plan LIV/58.3.I; thence south-eastwards along the boundaries of and including plot No. 1/13 of the said plan, plots Nos. 21/2, 21/3, 21, 21/4, 21/5 and 22 of the Government Survey Plan LIV/58.3.III to the south-eastern corner of the said plot No. 22 on Gladstone Street; thence south-westwards along the said Gladstone Street to its junction with Leontios Makheras Street; thence north-westwards along the said Leontios Makheras Street to the point where it meets the southern boundary of plot No. 49 of the Government Survey Plan LIV/58.2.III; thence westwards along the said boundary to Ayia Phylaxis Street; thence northwards along the said Ayia Phylaxis Street to the point of commencement, all which said area is shown coloured yellow and hatched red on the Government Survey Plan Serial No. 1330.

*Ayia Trias Quarter.*

The boundary commences at the junction of Zeno Street with Gladstone Street and proceeds north-eastwards along the said Gladstone Street to the south-eastern corner of plot No. 22 of the Government Survey Plan LIV/58.3.III; thence north-westwards along the boundaries of and excluding plots Nos. 22, 21/5, 21/4, 21, 21/3, 21/2 of the said plan and plot No. 1/13 of the Government Survey Plan LIV/58.3.I to the Vathia river at the north-eastern corner of the latter plot; thence eastwards along the said river to the point where it crosses Anapafsis Street; thence north-eastwards along the said Anapafsis Street to its junction with a street which is a continuation of Byron Street at the most northern point of plot No. 6 of the Government Survey Plan LIV/58.3.II; thence southwards along the said street to its junction with Canning Street at the Mile Post No. 53; thence eastwards along the said Canning Street to its junction with George V Street; thence north-eastwards along the said George V Street to the point where it crosses the Vathia river; thence southwards along the said river to the seashore; thence south-westwards along the seashore to the south-eastern corner of plot No. 235 of the Government Survey Plan LIV/58.6.III; thence north-westwards along the eastern boundary of the said plot to Christodoulos Haggipavlou Street at its junction with Crete Street; thence north-westwards along the said Crete Street to its junction with Ayios Andreas Street; thence north-eastwards along the said Ayios Andreas Street to its junction with Eleni Paleologina Street; thence north-westwards along the said Eleni Paleologina Street to its junction with Pavlos Melas Street; thence eastwards along the said Pavlos Melas Street to its junction with Zeno Street; thence north-westwards along the said Zeno street to the point of commencement, all which said area is shown coloured green on the Government Survey Plan Serial No. 1330.

*Ayia Napa Quarter.*

The boundary commences at the junction of Gladstone and George VI Streets and proceeds eastwards along the said Gladstone Street to its junction with Zeno Street; thence south-eastwards along the said Zeno Street to its junction with Pavlos Melas Street; thence westwards along the said Pavlos Melas Street to its junction with Eleni Paleologina Street; thence south-eastwards along the said Eleni Paleologina Street to its junction with Ayios Andreas Street; thence south-westwards along the said Ayios Andreas Street to its junction with Crete Street; thence south-eastwards along the said Crete Street to its junction with Christodoulos Haggipavlou Street; thence southwards crossing the said Christodoulos Haggipavlou Street to the north-eastern corner of plot No. 235 of the Government Survey Plan No. LIV/58.6.III; thence along the eastern boundary of the said plot No. 235 to the seashore; then south-westwards along the seashore to the south-western corner of plot No. 62/2 of the Government Survey Plan LIX/2.2.II; thence northwards along the western boundary of the said plot to Richard and Berengaria Street; thence northwards along the said Richard and Berengaria Street to its junction with Hermes Street; thence north-eastwards along the said street to the south-eastern corner of plot No. 46 of the said plan; thence northwards along the eastern boundaries of plots Nos. 46 and 45 to Spyros Araouzos Street; thence westwards along the said Spyros Araouzos Street to its junction with Syntagma Street; thence westwards along the said Syntagma Street to its junction with Richard and Berengaria Street; thence northwards along the said Richard and Berengaria Street to its junction with Victoria Street; thence northwards along the said Victoria Street to its junction with

Sparte Street; thence north-eastwards along the said Sparte Street to its junction with Kitiou Kyprianos Street; thence northwards along the said Kitiou Kyprianos Street to its junction with Athens Street; thence eastwards along the said Athens Street to its junction with George VI Street; thence northwards along the said George VI Street to the point of commencement, all which said area is shown coloured red and hatched black on the Government Survey Plan Serial No. 1330.

*Katholiki Quarter.*

The boundary commences at the north-western corner of plot No. 255 of the Government Survey Plan LIV/57 on the old bed of the Garyllis river and proceeds eastwards along the boundaries of and including plot No. 255 of the said plan, and plot No. 9 of the Government Survey Plan LIV/58 to the most northern point of the last mentioned plot on the Pitsillia-Limassol main road; thence south-eastwards along the said road for a distance of 150 feet approximately to the most western point of plot No. 36 of the said plan on the boundary of the village of Ayia Phyla; thence north-eastwards along the said village boundary to the point at which the Limassol-Ayia Phylaxis road crosses the Vathia river; thence southwards along the said road to the south-western corner of plot No. 49 of the Government Survey Plan LIV/58.2.II; thence eastwards along the southern boundary of the said plot to Leontios Makheras Street; thence southwards along the said Leontios Makheras Street to its junction with Gladstone Street; thence north-eastwards along the said Gladstone Street to its junction with George VI Street; thence southwards along the said George VI Street to its junction with Athens Street; thence westwards along the said Athens Street to its junction with Kitiou Kyprianos Street; thence southwards along the said Kitiou Kyprianos Street to its junction with Sparte Street; thence westwards and south-westwards along the said Sparte Street to its junction with Victoria and Eleftheria Streets; thence north-westwards along the said Eleftheria Street to its junction with Yildiz Street; thence westwards along the said street to the bridge over the old Garyllis river on the Limassol-Paphos main road; thence north-westwards along the old bed of Garyllis river to the point of commencement, all which said area is shown coloured violet on the Government Survey Plan Serial No. 1330.

*Ayios Antonios Quarter.*

The boundary commences at the north-western corner of plot No. 44 of Ayios Antonios Quarter (Government Survey Plan LIX/2.2.III) on the seashore and proceeds north-eastwards along Ayios Antonios Street to its junction with the Garyllis river; thence south-eastwards along the Garyllis river to the seashore; thence westwards along the seashore to the point of commencement, all which said area is shown coloured blue and hatched in red on the Government Survey Plan Serial No. 1330.

*Djami Djedid Quarter.*

The boundary commences at the most southern point of plot No. 15/3 of the Government Survey Plan LIX/2.1.IV on the seashore and proceeds northwards along the boundaries of and including plots Nos. 15/3 and 15/2, of the said plan and plots Nos. 14/1 and 14/4 of the Government Survey Plan LIX/2.1.II to Franklin Roosevelt Street; thence north-eastwards along the said Franklin Roosevelt Street and Bayazid Street to the Garyllis river; thence northwards along the Garyllis river to the

bridge carrying the Limassol-Paphos main road; thence eastwards along Yildiz Street to its junction with Eleftheria Street; thence south-eastwards along Eleftheria Street to its junction with Victoria Street; thence southwards along Victoria Street to its junction with Richard and Berengaria Street; thence southwards along Richard and Berengaria Street to its junction with Syntagma Street; thence eastwards along Syntagma Street to its junction with Spyros Araouzos Street at the north-eastern corner of plot No. 45 of Djami Djedid Quarter, Block IV (Government Survey Plan LIX/2.2.II); thence southwards along the boundaries of and including plots Nos. 45 and 46 of the said plan to Hermes Street; thence westwards along Hermes Street to its junction with Richard and Berengaria Street; thence southwards along Richard and Berengaria Street to the north-eastern corner of plot No. 62/1 of the said plan; thence southwards along the eastern boundary of the said plot No. 62/1 to the seashore; thence westwards along the seashore to the mouth of the Garyllis river; thence north-westwards along the Garyllis river to Ayios Antonios Street; thence southwards and south-westwards along Ayios Antonios Street to the seashore at the north-western corner of plot No. 44 of Ayios Antonios Quarter (Government Survey Plan LIX/2.2.III); thence westwards along the seashore to the point of commencement, all which said area is shown coloured yellow on the Government Survey Plan Serial No. 1330.

*Arnaout Quarter.*

The boundary commences at the junction of Franklin Roosevelt Street with Selim II Street and proceeds northwards along the said Selim II Street to plot No. 75 of Arnaout Quarter, Block II (Government Survey Plan LIX/2.1.I); thence south-westwards along the boundary of and including plot No. 75 of the said plan and plot No. 74 of Arnaout Quarter, Block II (Government Survey Plan LIX/2.1.I) to a point in a straight line with the southern boundary of plot No. 9/2 of Arnaout Quarter, Block II (Government Survey Plan LIX/2.1.I); thence north-westwards and northwards along the boundaries of and including plots Nos. 9/2, 9/3, 9/1, 10/1, 8, 7, 6, 5, 4, 3, 2, 1 and 1/1 of the said plan to the most northern point of the said plot No. 1 on the Limassol-Paphos main road; thence eastwards along the said Limassol-Paphos main road to its junction with a new street at the south-eastern corner of plot No. 11 of Arnaout Quarter, Block I of the Government Survey Plan No. LIV/58.4.III; thence north-eastwards along the said new street to the most southern point of plot No. 40/3 of the said plan; thence north-westwards and north-eastwards along the boundaries of and including plots Nos. 40/3, 40/1 and 40/2 of the said plan to Arnaout Street; thence north-westwards along the said Arnaout Street to the Garyllis river; thence south-eastwards along the Garyllis river to Bayazid Street; thence south-westwards along Bayazid Street and Franklin Roosevelt Street to the point of commencement, all which said area is shown coloured blue on the Government Survey Plan Serial No. 1330.

*Chiftlikoudhia Quarter.*

The boundary commences at the most southern point of plot No. 56/1 of the Government Survey Plan LIX/9 on the seashore and on the boundary of the village of Zakaki and proceeds northwards along the said village boundary to the north-western corner of plot No. 174 of the Government Survey Plan LIX/1 where it meets the boundary of the village of Kato Polemidhia; thence northwards along the last mentioned village boundary to the south-eastern corner of plot No. 162 of the

Government Survey Plan LIV/57 on the main road Limassol-Paphos; thence south-eastwards along the said main road to the bridge over the Garyllis river diversion; thence south-eastwards along the said Garyllis river to the bridge carrying Franklin Roosevelt Street; thence north-eastwards along the said Franklin Roosevelt Street to the most northern point of plot No. 14/4 of the Government Survey Plan LIX/2.1.II; thence southwards along the boundaries of and excluding plots Nos. 14/4, 14/1 of the said plan and plots Nos. 15/2 and 15/3 of the Government Survey Plan LIV/2.1.IV to the seashore; thence south-westwards along the seashore to the point of commencement, all which said area is shown coloured red and hatched blue on the Government Survey Plan Serial No. 1330.

*Ayios Ioannis Quarter.*

The boundary commences at the most southern point of plot No. 162 of the Government Survey Plan LIV/57 where a road to Polemidhia leaves the Limassol-Paphos main road and proceeds northwards along the first mentioned road to the north-western corner of plot No. 160 of the said plan, locality "Koutsoullia"; thence north-eastwards along the boundaries of and including plots Nos. 160, 157, 156, 155, 154, 137, 124 and 126 of the said plan to the most northern point of the said plot No. 126 on the right bank of the Garyllis river diversion; thence northwards along the said bank of this river diversion to its junction with the Garyllis river at the most northern point of plot No. 244 of the said plan; thence south-eastwards along the Garyllis river up to Arnaout Street, near plot No. 14/9 of the Government Survey Plan LIV/58.4.III; thence south-eastwards along the said Arnaout Street to the south-eastern corner of plot No. 13/3 of the said plan; thence south-westwards and south-eastwards along the boundaries of and excluding plots Nos. 40/2, 40/1 and 40/3 of Arnaout Quarter, Block I (Government Survey Plan LIV/58.4.III) to a street at the most southern point of the latter plot; thence south-westwards along the said street to the Limassol-Paphos main road; thence westwards along the said Limassol-Paphos main road to the most northern point of plot No. 1 of Arnaout Quarter, Block II (Government Survey Plan LIX/2.1.I); thence southwards and south-eastwards along the boundaries of and excluding plots Nos. 1, 1/1, 2, 3, 4, 5, 6, 7, 8, 10/1, 9/1, 9/3 and 9/2 of the said plan to a street at the most southern point of the last mentioned plot; thence south-westwards in a straight line to the north-western corner of plot No. 74 of the said plan; thence south-westwards along the western boundary of the said plot No. 74 and the western and southern boundary of plot No. 75 of Arnaout Quarter, Block II (Government Survey Plan LIX/2.1.I) to Selim II Street; thence southwards along the said Selim II Street to Franklin Roosevelt Street; thence south-westwards along the said Franklin Roosevelt Street to the bridge over the Garyllis river diversion; thence north-westwards along the said Garyllis river diversion to the bridge carrying the Limassol-Paphos main road; thence north-westwards along the said road to the point of commencement, all which said area is shown coloured brown on the Government Survey Plan [Serial No. 1330.
