## No. 417. THE LAND ACQUISITION LAWS, 1899 TO 1945.

### NOTIFICATION UNDER SECTIONS 2, 3 AND 4.

R. E. TURNBULL,  
Acting Governor.

Whereas it has been represented to me that it is desirable in the public interest to establish a permanent Military Camp at or near the locality Kolokosh in the District of Nicosia the cost whereof is to be borne by His Majesty's Military Authorities.

Now, therefore, I, Roland Evelyn Turnbull, Companion of the Most Distinguished Order of Saint Michael and Saint George, Acting Governor, by virtue of the powers vested in the Governor by sections 2, 3 and 4 of the Land Acquisition Laws, 1899 to 1945, do hereby declare the establishment of a permanent Military Camp as aforesaid to be an undertaking of public utility and do hereby authorize the carrying out of the said undertaking as aforesaid and do hereby entrust to Major Jack Hunter WALLACE, Deputy Assistant Director of Hirings, Claims and Disposals (Fixed Assets), H.Q. Cyprus District, the supervision and effectuation of the said undertaking as aforesaid.

**THE INCREASE OF RENT (RESTRICTION) LAWS, 1942 TO 1946.**

NOTIFICATION UNDER SECTION 4.
