THE AGRICULTURAL PRODUCE (EXPORT) LAW, 1933.

REGULATIONS MADE UNDER SECTION 8.

R. E. TURNBULL,

Acting Governor.

I, the Acting Governor in Council, in exercise of the powers conferred on the Governor in Council by section 8 of the Agricultural Produce (Export) Law, 1933, do hereby make the following regulations:-

1. These regulations may be cited as the Agricultural Produce (Sage Leaves) Export (Amendment) Regulations, 1946, and shall be read as one with the Agricultural Produce (Sage Leaves) Export Regulations, 1943, (hereinafter referred to as "the principal Regulations"), and the principal Supplement Regulations and these regulations may together be cited as the Agricultural Produce (Sage Leaves) Export Regulations, 1943 and 1946.

2. The principal Regulations are hereby amended by the insertion therein immediately after regulation 8 of the following regulation:-

"8A. Sage leaves which have not been passed by the inspector shall be removed from the place of inspection within 24 hours of the notification by the inspector of his refusal to pass such sage leaves for export:

Provided that the Director of Agriculture may in any case, if he thinks it expedient, extend the time within which such sage leaves

shall be removed from the place of inspection."

REGULATIONS MADE UNDER SECTION 8.

1. These regulations may be cited as the Agricultural Produce (Yellow-Leaf Tobacco) Export (Amendment) Regulations, 1946, and shall

be read as one with the Agricultural Produce (Yellow-Leaf Tobacco) Export Regulations, 1940, (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Agricultural Produce (Yellow-Leaf Tobacco)

Export Regulations, 1940 and 1946.

2. The principal Regulations are hereby amended by the insertion therein immediately after regulation 11 of the following regulation:-

"11A. Yellow-leaf tobacco which has not been passed by the inspector shall be removed from the place of inspection within 24 hours of the notification by the inspector of his refusal to pass such yellow-leaf tobacco for export:

Provided that the Director of Agriculture may in any case, if he thinks it expedient extend the time within which such yellow-leaf

tobacco shall be removed from the place of inspection.

## No. 46. THE DEFENCE (HEATERS CONTROL) ORDERS, 1944 TO (No. 2) 1945.

NOTIFICATION UNDER CLAUSE 3 (1).

In exercise of the powers vested in me under clause 3 (1) of the Defence (Heaters Control) Orders, 1944 to (No. 2) 1945, I hereby declare the 1st March, 1946, to be the date from and after which no person shall erect, use or work whithin the area of Episkopi, Limassol District, any wood burning heater of the following type without a licence from me, that is to say:

1. Bakers type ovens.

The Irrigation Divisions (Villages) Laws, 1938 and 1944.

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Laws, 1938 and 1944, the following rules made by the Committee of the Irrigation Division of Palekhori (Morphou) "Pera Avlaki and Kharkomatas", in the District of Nicosia, are published in the Gazette. IRRIGATION DIVISION OF PALEKHORI (MORPHOU) "Pera Avlaki and Kharkomatas" Rules.

1. These Rules may be cited as the Irrigation Division of Palekhori (Morphou) "Pera Avlaki and Kharkomatas" Rules, 1946.

2. In these rules, unless the context otherwise requires— "Commissioner" means the Commissioner of the District of

Nicosia;

'Committee" means the Committee of the Irrigation Division; "Irrigation Division" means the Irrigation Division of Palekhori (Morphou) "Pera Avlaki and Kharkomatas";

"Law" means the Irrigation Divisions (Villages) Laws, 1938

and 1944;

"list" means the list of the names and residence of the proprietors and of the lands and extent thereof which are to be benefited or are capable of being benefited by the works prepared under the provisions of section 15 of the Law as finally settled under the provisions of section 16 of the Law; "works" means the irrigation works of the Irrigation Division.
