No. 81. THE CUSTOMS (EXPORT DUTY) LAW, 1940.

ORDER IN COUNCIL No. 2183 MADE UNDER SECTION 65 (b).

C. C. WOOLLEY, Governor.

I, the Governor in Council, in exercise of the powers conferred by section 5 of the Customs (Export Duty) Law, 1940, do hereby order as follows:—

1. This Order may be cited as the Customs (Export Duty) (Goods for the United Nations Relief and Rehabilitation Administration) Order, 1946.

2. All rates of export duty set forth in the Schedule to the Customs (Export Duty) Law, 1940, or fixed in respect of goods added to such Schedule payable in respect of goods therein described, for the time being, which are certified by a properly authorized representative of the United Nations Relief and Rehabilitation Administration in Cyprus to be exported by or for the purposes of such administration, are cancelled.

3. This Order shall be deemed to have come into operation on the

1st day of October, 1945.

No. 82. THE CUSTOMS LAWS, 1936 TO (No. 2) 1945.

ORDER IN COUNCIL No. 2184 MADE UNDER SECTION 65 (b).

I, the Governor in Council, in exercise of the powers conferred by section 65 (b) of the Customs Laws, 1936 to (No. 2) 1945, do hereby order as follows:—

1. This Order may be cited as the Customs (Export Wharfage Dues) (Goods for the United Nations Relief and Rehabilitation Administration) Order, 1946.

- 2. All goods certified by a properly authorized representative of the United Nations Relief and Rehabilitation Administration in Cyprus to be exported by or for the purposes of such administration shall be exempt from the payment of any wharfage dues for export.
- 3. This Order shall be deemed to have come into operation on the 1st day of October, 1945.

THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1945.

ORDER IN COUNCIL No. 2185

MADE UNDER SECTION 116 (a) (i).

Authority to the Council of the Municipal Corporation of Lefka to contract a loan.

- I, the Governor in Council, in exercise of the powers conferred by section 116 (a) (i) of the Municipal Corporations Laws, 1930 to 1945, do hereby order as follows:—
- 1. That the Mayor, Deputy Mayor, Councillors and Townsmen of the Municipal Corporation of Lefka (hereinafter referred to as "the Municipal Corporation") shall be at liberty to borrow from the Government of Cyprus the sum of four hundred pounds (£400) at a rate of interest not exceeding two per centum (2%) per annum subject to the following terms and conditions, that is to say,—
 - (a) that the sum borrowed shall be repayable by the Municipal Corporation to the Government of Cyprus in five equal annual instalments (comprising sinking fund and interest), the first of such instalments being payable one year after the date of borrowing and all subsequent instalments being payable on the corresponding date of each year following until final repayment;
 - (b) that the Municipal Corporation shall, in each year and until final repayment of the sum borrowed, insert in the annual estimates as a charge on its revenues the annual sum payable as aforesaid in the year to which such estimates relate;
 - (c) that the sum borrowed shall be utilized to meet the deficit in the general account of the Municipal Corporation for the year 1945.
- 2. That for the purpose of securing the repayment of the above-mentioned sum the Municipal Corporation shall, subject to any prior encumbrances thereon, mortgage to the Government of Cyprus all the rates, fees and duties now payable or hereafter to become payable to the Municipal Corporation.
