**No. 179. THE CUSTOMS LAWS, 1936 TO 1946.**

**ORDER IN COUNCIL No. 2248**

**MADE UNDER SECTION 52.**

*WINSTER,*  
*Governor.*

I, the Governor in Council, in exercise of the powers conferred by section 52 of the Customs Laws, 1936 to 1946, do hereby order as follows :—

1. This Order may be cited as the Import Duty (Buttons Manufacture) Exemption Order, 1947.

2. All cardboard and all trocas shells imported into the Colony by any person who satisfies the Comptroller of Customs that—

- (a) he is a bona fide button manufacturer ; and
- (b) he imports—
  - (i) such cardboard for use in the packing of buttons for export ;
  - (ii) such trocas shells for the purpose of manufacturing buttons therefrom,

shall be admitted into the Colony free from all import duties :

Provided that, before clearance from the Customs, the importer shall sign a declaration in the form set out in the Schedule hereto.

3. This Order shall be deemed to have been made on the 1st March 1947.

**SCHEDULE.**

**THE IMPORT DUTY (BUTTONS MANUFACTURE) EXEMPTION ORDER, 1947.**

I, the undersigned....., of....., being the importer of the following \* cardboard/trocas shells, that is to say :—

.....  
 hereby declare as follows :—

\* (a) I have imported the said cardboard solely for use in the packing of buttons for export and for no other purpose ;

OR

\* (a) I have imported the said trocas shells for the purpose of manufacturing buttons therefrom and for no other purpose ;

\* Strike out whichever is inapplicable.

- (b) I agree that the Comptroller of Customs or any person authorized by him in that behalf shall, at all times, have the power and right to enter any premises or place wherein or whereon the said \* cardboard/trocas shells will be stored or manufactured for the purpose of inspecting such premises or place and for ensuring that the terms of this declaration are being complied with and I further agree and undertake to supply the Comptroller with any information which he may require touching such \* cardboard/trocas shells and the manner of disposal.
2. If I fail to observe the provisions of this declaration, I hereby agree and undertake to pay to the Comptroller, upon his request, the full import duty for the time being in force for any \* cardboard/trocas shells imported as aforesaid.

**No. 181. THE LAND ACQUISITION LAWS, 1899 TO 1947.**

NOTIFICATION UNDER SECTION 6.

In exercise of the powers vested in him by section 6 of the Land Acquisition Laws, 1899 to 1947, and with reference to the Notification dated the 8th day of November, 1946, and published under No. 367 in Supplement No. 3 to the *Gazette* of the 14th November, 1946, relating to the establishment of a permanent Reform School within the villages of Lapithos and Karavas, His Excellency the Governor has been pleased to sanction and hereby sanctions the acquisition, under the provisions of the aforesaid Laws, of the immovable properties situated in the villages of Lapithos (Ayios Loucas Quarter) and Karavas (Exo-Yitonia Quarter), in the District of Kyrenia, particulars whereof are specifically set out in the notice of the Commissioner, Nicosia and Kyrenia, published in Supplement No. 3 to the *Gazette* of the 6th February, 1947.
