

No. 87. THE CUSTOMS LAWS, 1936 TO 1946.

NOTIFICATION UNDER SECTION 66.

It is hereby notified that by virtue of the powers vested in the Governor by section 66 of the Customs Laws, 1936 to 1946, and duly deputed to me, I hereby approve the premises described in the third column of the Schedule hereto, belonging to the person whose name is set out in the first column of that Schedule and occupied by the firm whose name is set out in the second column of that Schedule, to be a private warehouse for the warehousing and securing of the goods specified in the fourth column of the said Schedule without payment of import duties upon the first entry of such goods therein.

THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1945.

BYE-LAWS MADE BY THE COUNCIL OF THE MUNICIPAL CORPORATION OF LIMASSOL.

In exercise of the powers vested in them by the Municipal Corporations Laws, 1930 to 1945, and otherwise, the Council of the Municipal Corporation of Limassol hereby make the following bye-laws :—

1. These bye-laws may be cited as the Municipal Corporation (Limassol) (Amendment) Bye-laws, 1947, and shall be read as one with the Municipal Corporation (Limassol) Bye-laws, 1931 to 1946, (hereinafter referred to as "the principal Bye-laws"), and the principal Bye-laws and these bye-laws may together be cited as the Municipal Corporation (Limassol) Bye-laws, 1931 to 1947.

2. The principal Bye-laws are hereby amended by the insertion therein immediately after bye-law 104 of the following chapter and bye-law :—

"Chapter 3A.—*Prophylactic Stations for Venereal Diseases.*

104A.—(1) No person shall keep or operate a prophylactic station for venereal diseases within the municipal limits without previously obtaining a licence from the Council :

Provided that no licence shall be granted to any person save on production by him of a certificate or other document signed by the Director of Medical and Health Services to the effect that he is experienced to keep and operate a prophylactic station.

(2) Every such licence shall expire on the 31st day of December next following the date of issue but it shall be subject to renewal yearly if the prophylactic station has been operated to the satisfaction of the medical officer of health.

(3) Any such licence may be revoked at any time by the council if on good cause shown the council considers it advisable so to do.

(4) The Director of Medical and Health Services or his representative, the medical officer of health, the mayor or a representative of the council authorized in writing in that behalf by the mayor, shall have the right, and the licensed person shall permit them, to enter and inspect at any time any premises used as a prophylactic station in order to ascertain whether it is properly worked and maintained in the interests of health ”.

3. The principal Bye-laws are hereby amended by the insertion therein immediately after bye-law 168 of the following part and bye-laws :

“ PART XIII.A.

REGULATIONS OF TRAFFIC.

168A.—(1) No person shall in the streets below mentioned, lead, ride, drive or take any animal or vehicle in the direction mentioned against the name of each street along the portions of the street specified :

*Helene Palaeologina Street* : The direction leading to St. Andrew Street along the whole street.

*Costa Kouzaris Street* : The direction leading to Helene Palaeologina Street, along the portion of the street which is between Pavlos Melas Street and Helene Palaeologina Street.

*Vassilios Makedon Street* : The direction leading to Pavlos Melas Street, along the portion of the street which is between St. Andrew Street and Pavlos Melas Street.

*Sir Walter Sendall Street* : The direction leading to St. Andrew Street, along the portion of the street which is between Themis Street and St. Andrew Street.

*Saripolos Street* : The direction leading to Socrates Street, along the portion of the street which is between St. Andrew Street and Socrates Street.

*Kitiou Kyprianou Street* : The direction leading to St. Andrew Street, along the whole street.

*Commandaria Street* : The direction leading to Spyros Araouzos Street, along the portion of the street which is between Genethlios Mitellas Street and Spyros Araouzos Street.

*Victoria Street* : The direction leading to Spyros Araouzos Street, along the portion of the street which is between the Retail Shop of the Cyprus Wine & Spirits Co., Ltd. and Spyros Araouzos Street.

*Genethlios Mitellas Street* : (a) The direction leading to Commandaria Street, along the portion of the street which is between the Second Municipal Market and Commandaria Street ;

(b) The direction leading to Commandaria Street, along the portion of the street which is between St. Andrew Street and Commandaria Street.

*Market Street* : The direction leading to the Second Municipal Market along the whole street.

*Christodoulos Hadjipavlou Street* : The direction leading towards the junction of Christodoulos Sozos and Christodoulos Hadjipavlou Streets, along the portion of the street which is between the end of Spyros Araouzos Street and the corner of Christodoulos Sozos Street.

*Spyros Araouzos Street* : The direction leading to Demetrios Nicolaidis Street, along the whole street.

*St. Andrew Street* : The direction leading towards the junction of Victoria and St. Andrew Streets, along the portion of the street which is between the junction of Christodoulos Sozos and St. Andrew Streets and the said junction of Victoria and St. Andrew Streets.
