THE WIDOWS' AND ORPHANS' PENSIONS LAW, 1947.

No. 2. **BY THE GOVERNOR.**

A PROCLAMATION.

WINSTER,
Governor.

Whereas there now exist in the District of Limassol two chiftliks which had hitherto been commonly known as Souni and Zanaja ;

And whereas it is expedient that the status of a village should be given to the said chiftliks ;

Now, therefore, in exercise of the powers vested in me by the Village Authorities Laws, 1931 to No. (2) 1937, and of every other power and authority enabling me, I, Reginald Thomas Herbert, Baron Winster of Witherslack, Privy Counsellor, Governor and Commander-in-Chief in and over the Colony of Cyprus, do hereby order and proclaim as follows :—

(1) that from and after the 1st day of January, 1948, the said chiftliks shall be constituted a village in the District of Limassol ;

(2) that the said village shall, for all administrative purposes, be ranked as a village under the style of " Souni-Zanaja " ;

(3) that the said village shall comprise the following areas, that is to say : (a) the area described in the First Schedule hereto, which was formerly included in the Village Lands of Pano Kividhes ; (b) the area described in the Second Schedule hereto, which was formerly included in the Village Lands of Sotira, and (c) the area described in the Third Schedule hereto, which was formerly included in the Village Lands of Kandou ;

(4) that all the areas described in the First, Second and Third Schedules hereto shall be transferred from the Village Lands of Pano Kividhes, Sotira and Kandou to the Village Lands of the said village of Souni-Zanaja.

SOUNI-ZANAJA VILLAGE.

FIRST SCHEDULE.

Lands transferred from the village of Pano Kividhes to the village of Souni-Zanaja.

The boundary commences at the north-western corner of Plot No. 197 of the Government Survey Plan No. LIII/19, locality "Yiazamanis" and proceeds eastwards along the northern boundaries of plots Nos. 197, 196, 195, 194, 193 and 192 of the said plan to the north-eastern corner of the said plot No. 192 on the road leading from the village of Kato Kividhes to the asphalted road from Limassol to Mallia; thence south-eastwards along the said road to its junction with the said asphalted road at the most eastern point of plot No. 191 of the said plan; thence westwards along the said asphalted road to the point at which it is joined by a footpath at the north-eastern corner of plot No. 190 of the said plan; thence southwards along the said footpath to the most southern point of the last mentioned plot; thence north-westwards along the boundaries of and including plots Nos. 190 and 189 of the said plan to the south-western corner of the last mentioned plot, which point is on a stream; thence southwards along the said stream to the south-eastern corner of plot No. 62 of the Government Survey Plan No. LIII/27, locality "Mavrou"; thence south-westwards along the boundaries of and including the last mentioned plot, plots Nos. 63, 64, 71, 72, 73, 74, 75, 76, 79 and 80, locality "Vathironas," plots Nos. 24, 81, 17, 16 and 14 of the said plan, plots Nos. 121, 120 and 119 of the Government Survey Plan No. LIII/19, locality "Vathironas"; thence eastwards along the boundaries of and including plots Nos. 120, 121, 122, 150, 148, 154, 153, 158, 159, 189, 190, 200 and 199 to the point of commencement.

This area is the area hatched blue on the Government Survey Plan Serial No. 1381.

SECOND SCHEDULE.

Lands transferred from the village of Sotira to the village of Souni-Zanaja.

The boundary commences at the north-western corner of plot No. 226 of the Government Survey Plan No. LIII/19, locality "Yiazamanis" and proceeds eastwards along the boundaries of and including plots Nos. 226, 227, 228, 231 and 232 of the said plan, plots Nos. 103, 102, 101, 100, 99, 78, 58, 57, 55, 54, 53, 51, 49, 48, 30, 31 and 32 of the Government Survey Plan No. LIII/20, plots Nos. 260, 259, 258, 278, 277, 257, 264, 265, 266, 267, 268, 270, 271, 272, 273 and 275 of the Government Survey Plan No. LIII/21, plots Nos. 1, 17 and 2 of the Government Survey Plan No. LIII/29, plots Nos. 29 and 30 of the Government Survey Plan No. LIII/28, plots Nos. 3, 4, 5, 6, 7, 11, 12, 13, 14, 15, 24, 25 and 26 to the south-eastern corner of plot No. 26 of the Government Survey Plan No. LIII/29, locality "Kamenos Stavros"; thence westwards along the boundaries of and including plots Nos. 26 and 27 of the said plan to the north-eastern corner of plot No. 187 of the Government Survey Plan No. LIII/28, locality "Myres Makries"; thence southwards along the boundaries of and including plots Nos. 187, 188 of the said plan, to the south-eastern corner of plot No. 217 of the Government Survey Plan No. LIII/36; thence westwards along the boundaries of and including plots Nos. 217 and 215 of the said plan to a stream at the south-western corner of the last mentioned plot; thence southwards along the said stream to the south-eastern corner of plot No. 191 of the said plan, locality "Platania"; thence westwards along the boundary of the said

plot to the asphalted road from Limassol to Mallia ; thence southwards along the said asphalted road to the south-eastern corner of plot No. 184 of the said plan ; thence westwards along the boundaries of and including plots Nos. 184, 182, 180, 178, 177 of the said plan, plots Nos. 79, 78, 73, 72, 70, 53, 48 and 42 of the Government Survey Plan No. LIII/44, locality " Kakotrin " to the most southern point of the last mentioned plot on the road leading from the village of Sotira to the village of Kandou ; thence north-westwards along the said road to the most eastern point of plot No. 144 of the Government Survey Plan No. LIII/36 where a footpath branches off ; thence northwards along the said footpath to its junction with another footpath at the most northern point of plot No. 57 of the Government Survey Plan No. LIII/35, locality " Paleokhanouta " ; thence south-westwards along the said footpath to the most southern point of plot No. 65 of the said plan, locality " Limnia " ; thence north-westwards along the western boundary of the said plot to the most southern point of plot No. 66 of the said plan ; thence westwards along the boundaries of and including plots Nos. 66, 68 and 69 to the south-western corner of plot No. 69 ; thence northwards along the boundaries of and including plots Nos. 69, 68, 66, 29, 31 and 32 of the said plan, plots Nos. 198, 193, 192, 188, 189 and 150 to a stream at the most southern point of the last mentioned plot of the Government Survey Plan No. LIII/27 ; thence northwards along the said stream to the most northern point of plot No. 240 of the Government Survey Plan No. LIII/19, locality " Latdjin " ; thence south-eastwards along the boundaries of and including plots Nos. 240 and 239 to the most northern point of plot No. 238 of the said plan ; thence northwards along the boundaries of and including plots Nos. 236, 231, 230 and 226 to the point of commencement.

This area is the area hatched yellow on the Government Survey Plan Serial No. 1381.

THIRD SCHEDULE.

Land transferred from the village of Kandou to the village of Scuni-Zanaja.

The boundary commences at the north-western corner of plot No. 63 of the Government Survey Plan No. LIII/29, locality " Myres Makries " and proceeds eastwards along the boundaries of and including plots Nos. 63 and 62 of the said plan to the north-eastern corner of the last mentioned plot ; thence southwards along the boundaries of and including plots Nos. 62, 63 and 64 to the south-eastern corner of plot No. 64 of the said plan ; thence westwards along the southern boundary of the last mentioned plot to the north-eastern corner of plot No. 30 of the Government Survey Plan No. LIII/37 ; thence southwards along the boundaries of and including plots Nos. 30, 31, 59 and 60 of the said plan, plots Nos. 13 and 21 to the most southern point of plot No. 21 of the Government Survey Plan No. LIII/45 ; thence north-westwards along the boundaries of and including plots Nos. 26, 27, 29 and 7 of the said plan, plot No. 84 of the Government Survey Plan No. LIII/44, plot No. 1 of the Government Survey Plan No. LIII/45, plots Nos. 49, 47, 46 and 43 of the Government Survey Plan No. LIII/37, plots Nos. 230 and 231 of the Government Survey Plan No. LIII/36 to the south-western corner of plot No. 231 on the asphalted road from Limassol to Mallia ; thence southwards along the said road to the south-eastern corner of plot No. 233 of the said plan ; thence north-westwards and northwards along the boundaries of and including plots Nos. 233, 234, 232, 229, 228, 223, 222, 221 and 218 of the said plan, plots Nos. 65 and 64 of the Government Survey Plan No. LIII/29 to the point of commencement.

This area is the area hatched green on the Government Survey Plan Serial No. 1381.
