**A PROCLAMATION.**

WINSTER,  
*Governor.*

Whereas it is expedient to amend the boundaries of the village of Sophtadhes and Tersephanou :

Now, therefore, in exercise of the powers vested in me by the Village Authorities Laws, 1931 to (No. 2) 1937, and otherwise, I, Reginald Thomas Herbert, Baron Winster of Witherslack, Privy Counsellor, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Governor and Commander-in-Chief in and over the Colony of Cyprus, do hereby order and proclaim that from and after the 15th day of July, 1948, the plots described in the Schedule hereto, heretofore reckoned within the boundaries of the village of Tersephanou in the District of Larnaca, shall form part of the lands of the village of Sophtadhes in the District of Larnaca and that the boundaries of the said villages of Sophtadhes and Tersephanou shall be altered accordingly.

Plots Nos. 171, 199, 200, 201 and 221 of the Government Survey Plan No. L/37 as shown edged in red on the Government Survey Plan Serial No. 1382.

**THE IRRIGATION DIVISIONS (VILLAGES) LAWS, 1938 AND  
1944 (Section 31)**

**AND**

**THE LAND ACQUISITION LAWS, 1899 TO 1947.**

**NOTIFICATION UNDER SECTION 6.**

In exercise of the powers vested in me by section 6 of the Land Acquisition Laws, 1899 to 1947, and with reference to the Notification dated the 7th day of February, 1948, and published under No. 62 in Supplement No. 3 to the *Gazette* of the 19th February, 1948, relating to certain land, situated in the village of Elea, in the District of Nicosia, and which is required for the construction of a new channel for the conveyance of water by the Irrigation Division of Elea, I, the Governor, do hereby sanction the acquisition, under the provisions of the

aforesaid Laws, of the immovable property situated in the village of Elea, particulars whereof are specifically set out in the notice of the Commissioner, Nicosia, published under Notification No. 92 in Supplement No. 3 to the *Gazette* of the 11th of March, 1948, to vest and be registered in the name of the Irrigation Division of Elea.

**No. 272. THE BURIALS LAWS, 1896 AND 1937.**

ORDER MADE UNDER SECTION 14.

Whereas in pursuance of Notification No. 196, published in *Gazette* Supplement No. 3 of the 10th July, 1947, a fit and proper site has been registered in the books of the Land Registry Office as a burial ground for the burial of the dead by the Orthodox-Christian Community of the village of Phrenaros, in the District of Famagusta:

Now, therefore, in exercise of the powers vested in the Governor by section 14 of the Burials Laws, 1896 and 1937, and duly delegated to me under Notification No. 172, published in Supplement No. 3 to the *Gazette* of the 19th June, 1947, I do hereby order that no burial shall take place in the burial ground in lieu whereof the new burial ground above referred to has been provided.
