## THE POST OFFICE LAWS, 1881 TO 1933.

ORDER IN COUNCIL No. 2308  
MADE UNDER SECTION 6.E. ST. J. JACKSON,  
*Acting Governor.*

In exercise of the powers vested in the Governor by section 6 of the Post Office Laws, 1881 to 1933, I, the Acting Governor, with the advice of the Executive Council, do hereby order as follows :—

1. This Order may be cited as the Parcels Post (Rates of Postage) (Amendment No. 9) Order, 1948, and shall be read as one with the Parcels Post (Rates of Postage) Orders, 1946 to (No. 8) 1948 (hereinafter referred to as "the principal Order"), and the principal Order and this Order may together be cited as the Parcels Post (Rates of Postage) Orders, 1946 to (No. 9) 1948.

2. The Schedule to the principal Order is hereby amended as follows :—

- (a) by the addition thereto in its alphabetical order of the new entry set out in the First Schedule hereto ;  
(b) by the deletion therefrom of the entries relating to the countries shown in the Second Schedule hereto and the substitution therefor of the entries relating to the same countries set out in the Second Schedule hereto.
